ORDINANCE 2014-13

AN ORDINANCE PROHIBITING BUSINESS ESTABLISHMENTS AND STORES FROM SELLING INTOXICATING LIQUORS, CIGARS OR CIGARETTES TO MINORS.

BE IT ORDAINED by the Sangguniang Bayan of Pavia, Iloilo in a regular session duly assembled that:

Section 1. Definition of Terms. For the purposes of this Ordinance, the following terms shall be construed:

- a) **Minors**- individual of any sex who are below eighteen (18) years of age.
- b) **Business Establishment**- a unit for occupation by selling any merchandise or article of commerce to the consumer public or profit gain.
- c) **Storekeeper**- refers to an owner or one in charge of , sales man or woman of a business establishment or store.
- d) **Store**- a structure where merchandise or article of commerce are sold to the consumer public for gain or profit.
- e) **Intoxicating Liquor** – any drink that produces inebriating effect caused by alcohol or fermented.
- f) **Natural person** – a common individual by birth.
- g) **Juridical person**- an organization, association or corporation operating in accordance with pertinent laws.

Section 2. Prohibition. The selling of intoxicating liquor, cigar or cigarettes to minors by any person (natural or juridical) is hereby prohibited.

Section 3. All business establishment or stores selling intoxicating liquors, cigars or cigarettes are hereby required to post in a prominent or conspicuous place of their business establishment or stores a legibly written notice that **“Selling of intoxicating liquors, cigars or cigarettes to minors is prohibited.”**

Section 4. Enforcement Clause. Members of the Pavia PNP, Barangay Tanod, Barangay Officials shall implement this ordinance.

Section 5. Penalty Clause. Any person natural, juridical, found guilty of violating any provision of this ordinance shall be penalized as follows:

On the first offense -A fine of P 1,500.00

On the 2nd offense -A fine of P 2,500.00 and suspension of business permit and license to operate for one (1) week in case of business entity or establishment

On the 3rd offense and succeeding offense -A fine of P 5,000.00 and cancellation or revocation of business permit and license in case of business entity or establishment

Due process shall be observed in the imposition of fines and suspension/revocation of business permit and license.

If the person decides voluntarily to served "Community Work" as penalty for violation of this ordinance, the person shall report for service to MSWD and be assigned to work within the period of the penalty and the MSWD will issue clearance for his community work served as evidence of complying the penalty of his violation.

Section 6. Repealing Clause. Any Ordinance or provision thereof found to be inconsistent with this Ordinance is deemed repealed.


Section 7. Effectivity Clause. This Ordinance shall take effect 15 days after a copy hereof is posted on the bulletin board at the entrance of the municipal hall and at least in two (2) conspicuous places in each barangay of this municipality and complying with publication requirements of the Local Government Code.

BE IT ORDAINED FURTHER, to furnish copies of this Ordinance to all Sangguniang Barangays, all Public Elementary Schools and High School in Pavia thru its Head Teacher/Principal for posting and to the Sangguniang Panlalawigan of the Province of Iloilo.


