ORDINANCE 2014-14

AN ORDINANCE TRANSFERRING ALL POSITIONS UNDER THE MUNICIPAL ECONOMIC ENTERPRISE OFFICE INTO THE ORGANIC OFFICES WHERE THEY CAME FROM SUCH AS THE MAYOR'S OFFICE, MUNICIPAL TREASURER'S OFFICE, AGRICULTURE OFFICE, RURAL HEALTH UNIT AND MUNICIPAL ENVIRONMENT AND NATURAL RESOURCES OFFICE, AND ABOLISHING THE MUNICIPAL ECONOMIC ENTERPRISE OFFICE.

WHEREAS, Section 76 of the Local Government Code provides that "Every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission";

WHEREAS, the Municipal Economic Enterprise Office (MEEEO) was created by virtue of the Municipal Ordinance Number 2011-18 dated July 18, 2011 which aimed to establish, develop, operate, maintain and manage sustainable municipal economic enterprises to generate revenue and enhance the delivery of public services for the advancement of the economic and social objectives of the municipality;

WHEREAS, pursuant to Section 6 of the said ordinance, filled-up existing positions formed part of the MEEEO staffing pattern and other positions not existing were deemed created except those positions which were supplied via transfer of positions from other department or office;

WHEREAS, upon assessment, the records showed that after three (3) years of its implementation, the income of the MEEEO for the three (3) major enterprises namely: Market and Slaughterhouse Unit; Lying-In, Dental and Laboratory Services Unit; Parks, Buildings, and Solid Waste Management was insufficient to fund its financial requirement. Hence, the deficiency was sourced from the General Fund as provided for under Section 3 of the said ordinance;

WHEREAS, the security of tenure of civil service officers and employees in the implementation of government reorganization is provided under RA 6656;

WHEREAS, Section 443 (c) (3) of the Local Government Code provides that "The Sangguniang Bayan may consolidate the functions of any office with those of another in the interest of efficiency and economy";

NOW THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF PAVIA, ILOILO, BY VIRTUE OF THE POWERS VESTED IN IT BY LAW, IN SESSION ASSEMBLED, THAT:

SECTION 1. TITLE. This ordinance shall be known as "AN ORDINANCE TRANSFERRING ALL POSITIONS UNDER THE MUNICIPAL ECONOMIC ENTERPRISE OFFICE INTO THE ORGANIC OFFICES WHERE THEY CAME FROM SUCH AS THE MAYOR'S OFFICE, MUNICIPAL TREASURER'S OFFICE, AGRICULTURE OFFICE, RURAL HEALTH UNIT AND MUNICIPAL ENVIRONMENT AND NATURAL RESOURCES OFFICE, AND ABOLISHING THE MUNICIPAL ECONOMIC ENTERPRISE OFFICE.

SECTION 2. ENFORCEMENT. The Local Chief Executive shall issue an Executive Order transferring all positions under the Municipal Economic Enterprise Office namely: Market and Slaughterhouse Unit; Lying-In, Dental and Laboratory Services Unit; Parks, Buildings, and Solid Waste Management back to the organic offices where they came from such as Mayor's Office, Municipal Treasurer's Office, Agriculture Office, Rural Health Unit, and Municipal Environment and Natural Resources Office.

SECTION 3. REPEALING CLAUSE. Municipal Ordinance 2011- 18 dated July 18, 2011 is hereby repealed, thereby abolishing the Municipal Economic Enterprise Office of the Municipality of Pavia, Iloilo.

SECTION 4. EFFECTIVITY. This ordinance shall take effect immediately.


