MUNICIPAL ORDINANCE 2017 – 05

ORDINANCE AMENDING PORTION OF ARTICLE XIII, SECTION 1B OF MUNICIPAL ORDINANCE NO. 2015-09 ENTITLED “ AN ORDINANCE ENACTING THE TRAFFIC CODE OF THE MUNICIPALITY OF PAVIA, ILOILO.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF PAVIA, ILOILO, BY VIRTUE OF THE POWERS VESTED IN IT BY LAW, IN SESSION ASSEMBLED, THAT:

SECTION 1. TITLE. This Ordinance shall be known and cited as the “ Ordinance Amending Portion of Article XIII, Section 1B of the Municipal Ordinance No. 2015-09 to include PCTODA.

“All Trisikad-for-Hire are hereby required to adopt the color coding scheme to every parking area designation as hereto/provided with designated numbers shall be amended to include **PCTODA as 2.15** in the list of the association; color assigned is silver, Route of operation shall be Public Market to all points of Purok 4 “.


SECTION 2. REPEALING CLAUSE. All previous issuance, ordinances, rules and regulations, or part thereof which are inconsistent or in conflict with the provisions of this Code are hereby repealed or modified accordingly.

SECTION 3. EFFECTIVITY. This Ordinance shall take effect upon compliance with the mandatory requirements prescribe under Republic Act 7160, otherwise known as the Local Government Code of 1991.

BE IT ORDAINED FURTHER, to furnish copies of this Ordinance to PCTODA, Pavia PNP, Municipal Treasurer's Office, Sangguniang Barangay of Purok IV, Pavia, Iloilo; Sangguniang Panlalawigan of the Province of Iloilo for review and other agencies for information and appropriate action.
