ORDINANCE 2017-12

AN ORDINANCE AMENDING SECTION 1.A, ARTICLE XIII OF THE MUNICIPAL TRAFFIC CODE OF THE MUNICIPALITY OF PAVIA, ILOILO TO INCLUDE POBLACION-UNGKA I-AGANAN ROUTE.

WHEREAS, the Local Government Code of 1991 provides, Section 447. Powers, Duties, Functions and Compensation.

(a) The Sangguniang Bayan, as the legislative body of the municipality, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code and in the proper exercise of the corporate powers of the municipality as provided for under Section 22 of this Code, and shall:

(3) Subject to the provisions of Book II of this Code, grant franchises, enact ordinances authorizing the issuance of permits or licenses, or enact ordinances levying taxes, fees and charges upon such conditions and for such purposes intended to promote the general welfare of the inhabitants of the municipality, and pursuant to this legislative authority shall:

(vi) Subject to the guidelines prescribed by the Department of Transportation and Communications, regulate the operation of tricycles and grant franchises for the operation thereof within the territorial jurisdiction of the municipality;

NOW THEREFORE, PREMISES CONSIDERED, AND UPON THE RECOMMENDATION OF THE SB COMMITTEE ON TRANSPORTATION,

BE IT ORDAINED by the Sangguniang Bayan of PAVIA, ILOILO in a REGULAR SESSION duly assembled, that:

Section 1. Title. Ordinance amending Section 1, Article XIII of the Municipal Traffic Code of the Municipality of Pavia, Iloilo to include Poblacion-Ungka I-Aganan, be approved, to wit:

- a. All Motorized Tricycle-for-Hire are hereby required to adopt the color coding scheme for every route of operation hereto or provided with design number and a Signboard with their Color on Top of the MTH.

1.2 Poblacion -PNHS -Anilao - Pagsanga-an	Green
1.3 Poblacion -PNHS - Tigum - Pagsanga-an	Red
1.4.A. Poblacion -PNHS -Aganan - Balabag - (Sta.Barbara)	Violet
1.4.B. Poblacion -PNHS -Aganan - Balabag	Blue
1.5 Poblacion -PNHS -Aganan - Pandac - Jibao-an	Silver
1.6 Poblacion -PNHS -Aganan - Pandac - Westville - Bangga 5	Pink
1.7 Poblacion -PNHS -Ungka 1	Yellow Green
1.8 Ungka II- Ungka I Railway	Sky Blue
1.9 Poblacion -PNHS-Cabugao Sur- Railway Road	Orange
1.10 Poblacion- Mali-ao - Pal-agon - Amparo	Yellow
1.11 Poblacion-Ungka I-Aganan	Dark Blue

Section 2. Repealing Clause. All ordinances, as well as pertinent rules and regulations thereof, which are inconsistent with the provisions of this ordinance are hereby repealed or amended accordingly.

Section 3. Effectivity. This Ordinance shall take effect immediately after complying the requirements provided for in the Local Government Code.


BE IT ORDAINED FURTHER, to furnish copies of this Ordinance to all concerned agencies for information and appropriate action.
