MUNICIPAL ORDINANCE 2019-01

**ORDINANCE APPROVING THE EXTENSION FOR THE PAYMENT OF BUSINESS TAXES
WITHOUT SURCHARGE OR PENALTY IN THE MUNICIPALITY OF PAVIA, ILOILO UNTIL
JANUARY 31, 2019.**

WHEREAS, the Municipal Revenue Code of the Municipality of Pavia, Iloilo approved on March 26, 2018 provides that: "Section 2E.03-Time of Payment. The tax shall be paid within the first twenty (20) days of January or in quarterly installments within the first twenty (20) days of January, April, July, and October of each year. The Sangguniang Bayan may, for a justifiable reason or cause, extend the time for payment of such taxes without surcharges or penalties, but only for a period not exceeding six (6) months.

WHEREAS, as represented by the ICO Municipal Treasurer – Ms. Caroline Teruel and endorsed by the Local Chief Executive, there is a need to extend the deadline on the payment of business taxes and renewal of permits and licenses to January 31, 2019, without penalties and surcharges to accommodate the volume of taxpayers queuing at the Municipal Hall in order to beat the deadline;

NOW THEREFORE, on motion of Honorable Danilo G. Hubag, and duly seconded unanimously,

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF PAVIA, ILOILO, BY VIRTUE OF THE POWERS VESTED IN IT BY LAW, IN SESSION ASSEMBLED, THAT:

Section 1. Title. Ordinance approving the extension for the payment of business taxes without surcharge or penalty in the Municipality of Pavia, Iloilo until January 31, 2019, be approved.


Section 2. Repealing Clause. All ordinances, as well as pertinent rules and regulations thereof, which are inconsistent with the provisions of this ordinance are hereby repealed or amended accordingly.


Section 3. Effectivity. This Ordinance shall take effect immediately after complying the requirements provided for in the Local Government Code.


BE IT ORDAINED FURTHER, to furnish copies of this Ordinance to all concerned agencies for information and appropriate action.
