**MUNICIPAL ORDINANCE 2019-02**

**ORDINANCE PROHIBITING ALL CARGO TRUCKS/TRAILERS/TANKERS FROM  
PASSING ALONG FELIX GORRICETA AVENUE AND ANGELA AVENUE FROM 6:30  
TO 8:00 IN THE MORNING AND 4:30 TO 7:00 IN THE EVENING, MONDAY TO  
FRIDAY, AND PROVIDING PENALTY FOR VIOLATION THEREOF.**

**WHEREAS**, the number of delivery trucks and other big vehicles plying along the Felix Gorriceta Avenue and Angela Avenue continues to increase thereby causing more traffic congestion;

**WHEREAS**, vehicular traffic congestion has been a problem of the citizens living in Aganan, Balabag, Pandac and Jibao-an in the Municipality of Pavia and also spawned other problems such as noise pollution, air pollution, vehicular accidents and traffic jams;

**WHEREAS**, RA 7160, otherwise known as "The Local Government Code of 1991," delegates to every Local Government Unit the power and authority to ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

**WHEREAS**, there is a pressing need to craft and formulate new truck regulations to respond to the pressing needs to alleviate traffic congestions at Felix Gorriceta Avenue and Angela Ave.

**WHEREAS**, it is imperative for the Local Government of the Municipality of Pavia to devise ways to solve vehicular traffic congestion to improve the general welfare and the economy of the municipality;

**WHEREAS**, the Local Government of the Municipality of Pavia wishes to improve the traffic management along Felix Gorriceta Ave and Angela Avenue;

**BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF PAVIA, ILOILO, BY VIRTUE OF THE POWERS VESTED IN IT BY LAW, IN SESSION ASSEMBLED, THAT:**

**Section 1. Title.** Ordinance prohibiting all cargo trucks/trailers/tankers from passing along Felix Gorriceta Avenue and Angela Avenue from 6:30 to 8:00 in the morning and 4:30 to 7:00 in the evening, Monday to Friday, and providing penalty for violation thereof, be approved.

**Section 2. Policy Statement.** There is hereby established a Truck Ban Ordinance of the Municipality of Pavia guided by expressed policies under Article 2, Section 5 of the Philippine Constitution that states, "the maintenance of peace and order, the protection of life, and liberty, and property, and promotion of the general welfare are essential for the enjoyment by all the people of the blessings of democracy".

**Section 3. Definition of Terms.** As used in this ordinance, the following shall be construed to mean as follows.

3.1 Cargo Trucks — motor vehicles, principally intended for carrying cargo and having license plates of the following classifications: "S", "T", "TC", "TH", "TRLB", "HHB", and "TRJ", to include other vehicles such as lorries, vans, tankers or other delivery vehicles, whether loaded or empty, having 6 wheels and above, having a gross capacity weight of more than 4,500 kilos.

**Section 4. Coverage.** This Ordinance shall apply to all cargo trucks with 6 wheels and above, having a gross capacity weight of more than 4,500 kilos which are hereby restricted or prohibited from driving, passing or parking from 6:30am to 8:00am and 4:30 pm to 7:00 pm, Monday thru Friday except government vehicles/equipment along Felix Gorriceta (Barangay Aganan, Barangay Pandac and Barangay Jibao-an) and Angela Avenue at Barangay Balabag, Pavia Iloilo.

**Section 5. Penalties.** The driver of the cargo trucks who violates the provision/s of this ordinance shall be penalized with a fine of 500.00 to be paid at the Municipal Treasurer's Office and/or the subject motor vehicle shall be impounded by the deputized law enforcer. In case of the insolvency of the driver, the owner of the cargo trucks shall be subsidiarily liable.

**Section 6. Signages.** Signages to this effect shall be placed in conspicuous places within the respective places.

**Section 7. Repealing Clause.** All Ordinances or any part thereof, which are contrary to or inconsistent with the provision of this Ordinance are hereby repealed or amended accordingly.


**Section 8. Separability Clause.** If for any reason, any section or provision of this Ordinance shall be declared unconstitutional or invalid, the other provisions not declared and not affected by such declaration shall remain in full force and effect.

**Section 9. Effectivity Clause.** This ordinance shall take effect thirty days after the publication in a newspaper of general circulation.


**BE IT ORDAINED FURTHER,** to furnish copies of this Ordinance to all concerned agencies for information and appropriate action.
