MUNICIPAL ORDINANCE 2019-04

ORDINANCE AMENDING PORTION OF “ARTICLE 18, SECTION 2. TRISIKAD OF THE MUNICIPAL ORDINANCE NO. 2015-09 ENTITLED THE TRAFFIC CODE OF THE MUNICIPALITY OF PAVIA, AND PROVIDING PENALTIES FOR VIOLATION THEREOF.”

WHEREAS, the different accredited Trisikad Associations in the Municipality of Pavia submitted their letter to the Sangguniang Bayan of Pavia requesting for fare rate increase;

WHEREAS, on the merit of the request and petitions for fare rate adjustments, the SB Committee on Transportation conducted public hearing;

WHEREAS, the ordinance recognizes and retain the fare discount privileges to students, senior citizen and PWD’s of the municipality in line with its social policies;

WHEREFORE, be it enacted by the Sangguniang Bayan in session assembled that:

SECTION 1. Section 2, Article 18 of Municipal Ordinance 2015-09 be amended to read:

TRISIKAD

1. The fare should be Php. 10.00 per passenger from Parking/Terminal area to point of destination.
 2. Any special trip requested by a passenger, the minimum fare allowed is Php 20.00.

3. The senior citizens, PWDs and students can avail the 20% discount, but there will be no discount on special trip.

SECTION 2. All previous issuances, ordinances, rules and regulations, or part thereof which are inconsistent or in conflict with the provisions of this Ordinance are hereby repealed or modified accordingly.


SECTION 3. This Ordinance shall take effect upon compliance with the requirements prescribe under Republic Act 7160, otherwise known as the Local Government Code of 1991.


