ORDINANCE NO. 2019- 09

ORDINANCE FOR THE TEMPORARY CLOSURE OF THE ROAD FROM C1 CENTRO VERDE TO THE PRESIDENT CORAZON AQUINO AND THE SENATOR BENIGNO AQUINO, JR. INTERSECTION (RIGHT SIDE ONLY) AND FROM COR-NI INTERSECTION TO ILOILO CITY BOUNDARY -PETRON (RIGHT SIDE ONLY), WITHIN THE JURISDICTION OF PAVIA, ILOILO FOR THE 8TH HEROES RUN ON NOVEMBER 24, 2019.

WHEREAS, there is a necessity for the temporary closure of portions of the above-mentioned roads to ensure the safety of the participants for the 8TH Heroes Run on November 24, 2019;

NOW THEREFORE, PREMISES CONSIDERED, AND UPON THE RECOMMENDATION OF THE SB COMMITTEE ON TRANSPORTATION, BE IT ORDAINED by the Sangguniang Bayan of Pavia, Iloilo in a REGULAR SESSION duly assembled, that:

Section 1. The road from C1 Centro Verde to COR-NI Intersection (right side only) and from COR-NI Intersection to Iloilo City Boundary-Petron (right side only), within the jurisdiction of Pavia, Iloilo be temporarily closed from 4:00 A.M. to 8:30 A.M. on November 24, 2019 for the 8th Heroes Run.


Section 2. The Pavia PNP, barangay concerned and Traffic Aides be furnished copies of this ordinance for their information and appropriate action. The enforcement of the closure shall be subject to the prior announcement or information dissemination at the expense of the organizers for at least three (3) consecutive days prior to the scheduled closure;

Section 3. This ordinance shall take effect upon approval.


