MUNICIPAL ORDINANCE 2020-07

ORDINANCE APPROVING THE EXTENSION OF PAYMENT ON UNPAID TAXES, FEES, AND CHARGES IN THE MUNICIPALITY OF PAVIA, ILOILO WITHOUT PENALTIES, SURCHARGES OR INTERESTS (EMBODIED IN THE MUNICIPAL REVENUE CODE OF 2018) COVERING THE PERIOD OF SECOND AND THIRD QUARTERS OF 2020 PURSUANT TO RA 11469 KNOWN AS "BAYANIHAN TO HEAL AS ONE ACT", REPEALING MUNICIPAL ORDINANCE 2020-06 DATED MARCH 23, 2020.

WHEREAS, pursuant to Proclamation No. 922, Series of 2020 issued by President Rodrigo R. Duterte, declaring a State of Public Health Emergency throughout the Philippines due to COVID-19, Section 2 provides that "All government agencies and LGUs are hereby enjoined to render full assistance, and cooperation and mobilize the necessary resources to undertake critical, urgent, and appropriate response and measures in a timely manner to curtail and eliminate the COVID-19 threat;

WHEREAS, the Proclamation No. 929 was issued declaring a state of calamity throughout the Philippines due to Corona Virus Disease 2019 (COVID-19) that imposed enforcement of Enhanced Community Quarantine (ECQ) throughout Luzon with the rest of the entire country declared under the State of Public Health Emergency;

WHEREAS, on March 25, 2020, the President signed into law Republic Act No. 11469 known as "Bayanihan to Heal as One Act to promote and adopt a whole of nation approach as it seeks to mobilize all sectors, both private and public to intensify existing COVID-19 response and preventive measures and to further mitigate the social, economic, and financial impact of Covid-19;

WHEREAS, temporary closure of business due to Stay at Home and social distancing policy brought about disruption of the normal course of economic activities;

WHEREAS, as represented by the ICO Municipal Treasurer – Ms. Caroline Teruel and endorsed by the Local Chief Executive, there is a need to suspend the penalties, surcharges and interest due for the period covering the Second and Third Quarters of 2020 particularly those pertaining to **SECTION 2.E.04- SURCHARGES AND PENALTIES ON UNPAID TAXES, FEES OR CHARGES and SECTION 2.E.05- INTEREST ON UNPAID TAXES, MUNICIPAL REVENUE CODE OF 2018.**

NOW THEREFORE, on motion of Honorable Daisy O. Hubero, and duly seconded by Honorable Mark Anthony H. Sotomil,

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF PAVIA, ILOILO, BY VIRTUE OF THE POWERS VESTED IN IT BY LAW, IN SESSION ASSEMBLED, THAT:

Section 1. Title. This ordinance shall be known as "An ordinance that allows the extension of payment on unpaid taxes, fees, and charges in the Municipality of Pavia, Iloilo without penalties, surcharges or interest (embodied in the Municipal Revenue Code of 2018) covering the period of Second and Third Quarters of 2020 pursuant to RA 11469 known as Bayanihan to Heal as One Act", repealing Municipal Ordinance 2020-06 dated March 23, 2020.

Section 2. Objective. This ordinance aims to help the different stakeholders in the municipality that are affected by the strict and extended implementation of the Enhanced Community Quarantine and prevent economic conditions from worsening brought by COVID-19 pandemic;

Section 3. Repealing Clause. All ordinances, particularly Municipal Ordinance 2020-06 dated March 23, 2020, as well as pertinent rules and regulations thereof, which are inconsistent with the provisions of this ordinance are hereby repealed or amended accordingly.

Section 4. Effectivity. This Ordinance shall take effect immediately after complying the requirements provided for in the Local Government Code.

BE IT ORDAINED FURTHER, to furnish copies of this Ordinance to all concerned agencies for information and appropriate action.

ENACTED this 20th day of April, 2020 at Pavia, Iloilo, Philippines.


