MUNICIPAL ORDINANCE 2020-08

ORDINANCE CREATING A SPECIAL ACCOUNT IN THE GENERAL FUND (SAGF) OF THE MUNICIPALITY OF PAVIA, ILOILO FOR THE BAYANIHAN GRANT TO CITIES AND MUNICIPALITIES (BGCM) PURSUANT TO SECTION 313 OF RA 7160.

WHEREAS, presented for consideration of the August Body is the request from the Local Chief Executive dated April 17, 2020 for the enactment of the above-mentioned ordinance;

WHEREAS, on March 25, 2020, the President signed into law Republic Act No. 11469 known as "Bayanihan to Heal as One Act" to promote and adopt a whole of nation approach as it seeks to mobilize all sectors, both private and public to intensify existing COVID-19 response and preventive measures and to further mitigate the social, economic, and financial impact of Covid-19;

WHEREAS, under Section 4(g) of RA 11469, the President is empowered to ensure that all local government units are acting within the letter and spirit of all the rules, regulations and directives issued by the National Government pursuant to the said law, and are implementing standards of Community Quarantine consistent with what the National Government has laid down for the subject area, while allowing the LGUs to continue exercising their autonomy on matters undefined by the National Government or are within the parameters it has set, and are fully cooperating towards a unified, cohesive and orderly implementation of the national policy to address COVID-19;

WHEREAS, the Department of Budget and Management (DBM) issued Local Budget Circular (LBC) No. 125 dated April 7, 2020 relative to the "Guidelines on the Release and Utilization of the Bayanihan Grant to Cities and Municipalities (BGCM), in which the Municipality of Pavia, Iloilo has an allocated amount of ELEVEN MILLION,EIGHT HUNDRED SIXTY THREE THOUSAND NINE HUNDRED FORTY NINE PESOS (Php 11,863,949.00);

WHEREAS, Section 3.7 requires the enactment of this ordinance pursuant to Section 313 of the Local Government Code of 1991, to wit: "Depository Accounts- Local Treasurers shall maintain depository accounts in the name of their respective local government units with banks, preferably government-owned, located in or nearest to their respective areas of jurisdiction."

NOW THEREFORE, on motion of Honorable Maria Jaspe Francisco, and duly seconded by Honorable Hanson H. Guyos,

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF PAVIA, ILOILO, BY VIRTUE OF THE POWERS VESTED IN IT BY LAW, THAT:

Section 1. Title. This ordinance shall be known as "ORDINANCE CREATING A SPECIAL ACCOUNT IN THE GENERAL FUND (SAGF) OF THE MUNICIPALITY OF PAVIA, ILOILO FOR THE BAYANIHAN GRANT TO CITIES AND MUNICIPALITIES (BGCM) PURSUANT TO SECTION 313 OF RA 7160."

Section 2. Objective. Pursuant to Section 3.7 of DBM-LBC No. 125 dated April 7, 2020, this special account is created for easy monitoring and tracking of the utilization of the allocation of each city/municipality;

Section 3. Effectivity. This Ordinance shall take effect immediately.

BE IT ORDAINED FURTHER, to furnish copies of this Ordinance to all concerned agencies for information and appropriate action.

ENACTED this 20th day of April, 2020 at Pavia, Iloilo, Philippines.




