**MUNICIPAL ORDINANCE 2020-10**

**ORDINANCE APPROVING THE CREATION OF FOUR (4) POSITIONS FOR THE FOLLOWING OFFICES: 1).MUNICIPAL PLANNING AND DEVELOPMENT OFFICE- PLANNING OFFICER IV (SG 22); 2). OFFICE OF THE MUNICIPAL ASSESSOR- COMPUTER OPERATOR II (SG 9); 3). MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICE- MUNICIPAL GOVERNMENT ASSISTANT DEPARTMENT HEAD(SG 22); 4). OFFICE OF THE MUNICIPAL ENGINEER- SENIOR ADMINISTRATIVE ASSISTANT II (SG 14) IN THE MUNICIPALITY OF PAVIA, ILOILO.**

**WHEREAS**, the Office of the Sangguniang Bayan received documents on May 20, 2020 as reference for the above-mentioned measure;

**WHEREFORE**, be it enacted by the Sangguniang Bayan in a special session assembled that:

**SECTION 1.** The Four (4) New Positions shall be created, as follows:

**1).MUNICIPAL PLANNING AND DEVELOPMENT OFFICE- PLANNING OFFICER IV (SG 22);**

2). OFFICE OF THE MUNICIPAL ASSESSOR- COMPUTER OPERATOR II (SG 9);

3). MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICE- MUNICIPAL GOVERNMENT ASSISTANT DEPARTMENT HEAD(SG 22);

4). OFFICE OF THE MUNICIPAL ENGINEER- SENIOR ADMINISTRATIVE ASSISTANT II (SG 14)

**SECTION 2.** The Municipality of Pavia, Iloilo shall appropriate budget for the implementation of this ordinance.

**SECTION 3.** This Ordinance shall take effect upon complying the requirements prescribed under Republic Act 7160, Civil Service Commission and other related Agencies.

**BE IT ORDAINED FURTHER,** to furnish copies of this Ordinance to the Sangguniang Panlalawigan of the Province of Iloilo for review, Civil Service Commission, DILG and other agencies for information and appropriate action.

**ENACTED** this 21<sup>st</sup> day of May, 2020 at Pavia, Iloilo, Philippines.


