MUNICIPAL ORDINANCE NO. 2020-13

ORDINANCE ON MANDATORY WEARING OF FACE MASK OF ALL PERSONS OUTSIDE THEIR RESIDENCES AND OBSERVANCE OF SOCIAL DISTANCING DURING ECQ, MECQ, GCQ, MGCQ OR ANY EXTENSION THEREOF AND UP TO THE NEW NORMAL AND FOR OTHER PURPOSES.

WHEREAS, Article II, Section 15 of the 1987 Constitution provides that the state shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, Section 16 of the Republic Act No. 7160 of the Local Government Code of 1991 provides that every Local Government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential for the promotion of the general welfare;

WHEREAS, pursuant to Republic Act No. 11332, it is the policy of the state to protect and promote the right to health of the people and shall endeavor to protect the people from the public health threats and the state recognizes epidemics and other public health emergencies as threats to public health and national security which can undermine the social, economic and political functions of the State;

NOW, THEREFORE, BE IT ENACTED BY THE SANGGUNIANG BAYAN OF PAVIA, ILOILO THAT:

SECTION 1. SHORT TITLE. This Ordinance shall be known as: "MANDATORY WEARING OF FACE MASKS AND SOCIAL DISTANCING ORDINANCE."

SECTION 2. COVERAGE. All persons who are found within the territorial jurisdiction of the Municipality of Pavia, Iloilo, are covered by this Ordinance.

SECTION 3. MANDATORY WEARING OF FACE MASKS. Every person within the territorial jurisdiction of the Municipality of Pavia, Iloilo are required to wear face mask at all times when they are outside their residences, in the work place, in the public places such as public markets, supermarkets, department stores, public plaza, churches, mall, restaurants, gymnasium, streets and the like.

Government offices and business establishments shall not allow the entry of individuals without a face mask.

SECTION 4. DEFINITION OF TERM

FACE MASK is a protective mask, whether indigenous, reusable, homemade or do-it-yourself mask, face shields and handkerchiefs, that can reduce risks of local transmission of the virus.

A face mask shall be worn properly. It should fit comfortably which covers both the nose and mouth of the person.

SECTION 5. OBSERVE SOCIAL DISTANCING. All persons in the Municipality of Pavia are required to observe social or physical distancing of a minimum of one meter or three (3) feet from one another.

SECTION 6. OTHER REQUIREMENTS FOR BUSINESS ESTABLISHMENTS. All business establishment owners or managers shall provide foot bath, hand sanitizer or hand washing area and the like at the entrance of their respective establishments intended for their customers.

SECTION 7. OTHER REQUIREMENTS FOR TOURISM ESTABLISHMENTS. All tourism establishments in the Municipality of Pavia are required to provide wash area, hand sanitizer and foot bath for their guests or customers.

SECTION 8. PENALTIES. Not wearing of face mask in the public places shall be penalized as follows:

A. Any person who fails to wear a face mask shall be meted out of the following penalties:

1. First Offense: Reprimand
2. Second Offense: A fine of One Thousand Pesos (P 1,000.00) or imprisonment for a period of Two (2) days or both at the discretion of the court



3. Third Offense and subsequent offenses: Fine of P2,000.00 and/or imprisonment for a period of Three (3) days or both at the discretion of the court.

B. Private establishment which violates this ordinance shall be penalized by the following:

1. First Offense: Reprimand
2. Second Offense: A fine of One Thousand Pesos (P 1,000.00) or imprisonment for a period of Two (2) days or both at the discretion of the court
3. Third Offense and subsequent offenses: Fine of P2,000.00 and/or revocation of business permit and imprisonment of the owner or manager for a period of Three (3) days or both at the discretion of the court.

SECTION 9. ENFORCEMENT. All Punong Barangays and their authorized deputies, the Philippines National Police (PNP), and other enforcers as designated or deputized by the Municipal Mayor are directed to enforce this Ordinance.

SECTION 10. SEPARABILITY CLAUSE. If for any reason or reasons, any part or provision of this Ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 11. REPEALING CLAUSE. All Ordinances, Executive Orders issued by the Barangays within this Municipality which are inconsistent with any provision/s of this Ordinance are hereby repealed or modified accordingly.

SECTION 12. EFFECTIVITY CLAUSE. This Ordinance shall take effect upon approval of Municipal Mayor, and after posting at three (3) conspicuous places in this municipality and publication in a newspaper of general circulation. Further, this ordinance shall be in full force until revoked, repealed or subsequently modified.

BE IT ORDAINED FURTHER, to furnish copies of this Ordinance to the Sangguniang Panlalawigan of the Province of Iloilo for review, DILG and other agencies for information and appropriate action.

ENACTED this 26TH day of October, 2020 at Pavia, Iloilo, Philippines.


