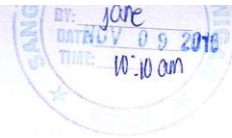

ORDINANCE NO. 2018 - 15

ORDINANCE DECLARING JANUARY 8, 2019 AS THE FIRST "ADLAW KANG PAVIA" AND PROVIDING FOR THE YEARLY OBSERVANCE THEREOF.

WHEREAS, Ordinance No. 2018-11 entitled "An Ordinance Establishing January 1, 1921 as the date of Independence of the Municipality of Pavia, Iloilo" was approved on the 17th of September, 2018;

WHEREAS, Executive Order No. 01 issued by the Office of the Governor-General of the Philippine Islands officially separating Pavia from Jaro and re-organizing it as an independent municipality, on which said ordinance was based, had been signed on January 8, 1921;

WHEREFORE, be it enacted by the Sangguniang Bayan in session assembled that:

SECTION 1. This Ordinance shall be known as "AN ORDINANCE DECLARING JANUARY 8, 2019 AS THE FIRST "ADLAW KANG PAVIA" AND PROVIDING FOR THE YEARLY OBSERVANCE THEREOF".

SECTION 2. In order to further enhance the cultural and historical enlightenment and social consciousness of Pavianhons, the Local Chief

Executive shall issue an Executive Order setting the activities for "Adlaw Kang Pavia".

SECTION 3. The Local Chief Executive shall be given the authority to allocate funds from source available in the Office of the Mayor.


Likewise, to encourage active participation of all constituents, the barangays should allocate funds from source available.

Moreover, to ensure a more meaningful observance of "Adlaw Kang Pavia" all government agencies and instrumentalities, local government offices, government-owned corporations, socio-civic groups, non-government organizations and private sectors within the locality are encouraged to devote sufficient time and to actively participate.


SECTION. 4. EFFECTIVITY. This Ordinance shall take effect upon approval.
