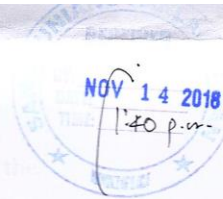

**ORDINANCE NO. 2018 - 17**

**ORDINANCE AMENDING ARTICLE II, SECTION 1 AND ARTICLE XVIII SECTION 2 OF THE MUNICIPAL ORDINANCE 2015-09 ENTITLED "TRAFFIC MANAGEMENT CODE IN THE MUNICIPALITY OF PAVIA, ILOILO AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF".**

**WHEREAS**, the different accredited MTH Associations in the Municipality of Pavia submitted their letter to the Sangguniang Bayan of Pavia requesting for tricycle fare rate increase due to the uncontrollable increase of gasoline, spare parts and other oil products;

**WHEREAS**, considering the increase of price of the gasoline and price of commodities, the existing fare cannot compensate the operational expenses incurred by the tricycle operators/drivers;

**WHEREAS**, the transport sector is vulnerable to the economic aftermath of oil price increase;

**WHEREAS**, on the merit of the request and petitions for tricycles fare rate adjustments, the SB Committee on Transportation conducted public hearing;

**WHEREAS**, the ordinance recognizes and retain the fare discount privileges to students, senior citizen and PWD's of the municipality in line with its social

**WHEREAS**, Title 2, Chapter 3, Article 3, Section 447.3.vi of the Local Government Code of 1991 provides "subject to the guidelines prescribed by the Department of Transportation and Communications, regulate the operation of tricycle and grant franchises for the operation thereof within the territorial jurisdiction of the Municipality."

**WHEREFORE**, be it enacted by the Sangguniang Bayan in session assembled that:

**SECTION 1.** Section 1, Article II of Municipal Ordinance 2015-09 be amended to include additional terms as follows:

*Student* – a person formally engaged in learning, especially one enrolled in a school or college;

*Persons with disability*—those suffering from restriction of different abilities, as a result of mental, physical or sensory impairment, to perform an activity in the manner or within the range considered normal for a human being.

**SECTION 2.** Section 2, Article XVIII shall be amended to read as follows:

"Section 2. The fare should be determined by the Sangguniang Bayan and in accordance with the LTFRB rulings:

**TRISIKAD**

The fare should be Php. 7.00 per passenger from Parking/Terminal area to point of destination.

The minimum fare allowed is Php 20.00 for any special trip requested by the passenger.

**SECTION 3.** All previous issuances, ordinances, rules and regulations, or part thereof which are inconsistent or in conflict with the provisions of this Ordinance are hereby repealed or modified accordingly.

**SECTION 4.** This Ordinance shall take effect upon compliance with the requirements prescribe under Republic Act 7160, otherwise known as the Local Government Code of 1991.

**BE IT ORDAINED FURTHER,** to furnish copies of this Ordinance to all Sangguniang Barangays for posting; Sangguniang Panlalawigan of the Province of Iloilo for review and other agencies for information and appropriate action.

**ENACTED** this 22<sup>nd</sup> day of October, 2018 at Pavia, Iloilo, Philippines.
