MUNICIPAL ORDINANCE 2023-09

ORDINANCE GRANTING FRANCHISE TO OPERATE MOTORIZED TRICYCLE FOR HIRE (MTH) TO RONNIE DELA ROSA.

BE IT ORDAINED by the Sangguniang Bayan of Pavia, Iloilo in a regular session duly assembled, that:

Section 1. Legal Basis. Section 447 (a) (3) (vi) of Republic Act 7160 otherwise known as the Local Government Code of 1991.

Section 2. Grant of Franchise. Franchise to operate tricycle-for-hire is hereby granted to the following:

Section 3. Franchise to Operate Motorcycle for Hire. The Grantee shall be issued a Franchise to Operate Motorcycle for Hire that shall be signed by the Chairperson and all the members of the Committee on Transportation and Franchising. The Franchise Confirmation shall be approved by the Municipal Mayor and shall be prominently displayed inside the sidecar of the tricycle unit at all times.

Section 4. Withdrawal, Cancellation, Revocation or Suspension of Franchise. In case of violation by the Grantee of the terms and conditions and/or requirements provided herein and pertinent laws, ordinances, rules and regulations now existing and those that may hereinafter be promulgated, the Municipality of Pavia, through the Sangguniang Bayan, has the right to withdraw, cancel, revoke or suspend the franchise.

Section 5. Repealing Clause. All ordinances, rules and regulations or parts thereof in conflict or inconsistent herewith are hereby repealed or modified accordingly.


Section 6. Separability Clause. In the event that any provision of this Ordinance is declared illegal, the validity of other provisions shall not be affected by such declarations which shall continue to be in full force and effect.

Section 7. Effectivity. This Ordinance shall take effect immediately, in accordance with the provisions of the Local Government Code of 1991.


BE IT ORDAINED FURTHER, to furnish copies of this Ordinance to all concerned agencies and individuals for information and appropriate action.

Subject: BUPTODA concerns

Findings and Recommendations:

The Commission related to the BUPTODA that this is their intra-company dispute but since the officers requested the SB Committee on Transportation to help them, the committee conducted the mediation meeting.

Facts:

On August 8, 2022, Mr. Romie de la Rosa submitted to the Sangguniang Bayan his Franchise Application.

On August 9, 2022, BUPTODA President David M. Bapista gave an endorsement letter to the Sangguniang Bayan stating the following:

1. Endorsement to allow Mr. Romie de la Rosa to operate a Motor Tricycle (MT) franchise as a member of the BUPTODA.
2. He is an old member of the previous TODA operating in Ungka 2, Pavia, Iloilo.
3. The BUPTODA members confirmed that Mr. Romie de la Rosa is qualified to operate.
