**MUNICIPAL ORDINANCE NO. 2023-18**

**ORDINANCE AMENDING SECTION 5, ARTICLE B (CHARGES FOR  
 PARKING) OF THE MUNICIPAL REVENUE CODE OF THE MUNICIPALITY  
 OF PAVIA, ILOILO.**

**WHEREAS**, the Municipal Revenue Code of the Municipality of Pavia,  
 Iloilo approved on March 26, 2018 provides "Charges for Parking" only;

**WHEREAS**, a Memorandum of Agreement was entered into between the  
 Municipality of Pavia, Iloilo and Robinsons Land Corporation relative to the  
 operation of Pavia Public Terminal as authorized by SB Resolution 2017-34;

**WHEREAS**, public hearing was conducted and the passage of the above-mentioned ordinance is hereby recommended as indicated in Committee Report 2023-102 dated July 17, 2023;

**NOW THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF PAVIA, ILOILO, BY VIRTUE OF THE POWERS VESTED IN IT BY LAW, IN SESSION ASSEMBLED, THAT:**

**Section 1. Title.** An ORDINANCE AMENDING SECTION 5, Article B (CHARGES FOR PARKING) OF THE MUNICIPAL REVENUE CODE OF THE MUNICIPALITY OF PAVIA, ILOILO, be approved to include the following:

*Section 5B.01.A Imposition of Fees for Parking. There shall be collected fees for the use of municipal owned parking area or designated streets for pay parking in accordance with the following schedule:*

(a) Parking Rates

<u>Vehicle Type</u>	<u>Daily</u>
Tricycle	Php 5.00
Taxi	15.00
Private Cars and Service Vehicles	20.00
Passenger Jeepneys	
Modernized Jeep/more than 20 Passengers	55.00
Traditional Jeep/20 or less passengers	10.00
MEX Jeep	15.00
Cargo Trucks/Delivery Vans	60.00
Passenger Bus	80.00

*Parking areas to be determined by the proper authorities upon enactment of an Ordinance.*

(b) Overnight Parking Rates – All types of vehicles Php100.00

(c) Towing Fee of Php 300.00 and impounding fee of P100.00/day shall be collected from owners of vehicles who shall violate the provisions of this Article. Each barangay shall assist the municipal government in ensuring compliance by car-owning residents with the

night-parking regulation and shall correspondingly receive a thirty percent (30%) share of the fees collected from its area of jurisdiction.

**Section 5B.01B** Imposition of Fees for Transport Terminal operated/managed by the Municipality of Pavia. The following charges shall be collected by the Municipal Treasurer's Office, to wit:

a. Parking Rates

<u>Vehicle Type</u>	<u>Rate</u>
Utility Vans	Php60.00/day
Bus	Php80.00/day
Passenger Jeepneys	
Modernized Jeep/more than 20 Passengers	Php55.00/day
Traditional Jeep/20 or less passengers	Php10.00/day
MEX Jeep	Php15.00/trip
Taxi	Php15.00/trip
Tricycle	Php 5.00/trip

**Section 2. Repealing Clause.** All ordinances, as well as pertinent rules and regulations thereof, which are inconsistent with the provisions of this ordinance are hereby repealed or amended accordingly.

**Section 3. Effectivity.** This Ordinance shall take effect immediately after complying the requirements provided for in the Local Government Code.

**BE IT ORDAINED FURTHER,** to furnish copies of this Ordinance to all Sangguniang Barangays for posting; Municipal Treasurer's Office, Sangguniang Panlalawigan of the Province of Iloilo for review and other agencies for information and appropriate action.

**ENACTED** on the 31<sup>st</sup> day of July, 20223 at Pavia, Iloilo, Philippines.


