MUNICIPAL ORDINANCE NO. 2023-30

AN ORDINANCE DECLARING THE THIRD WEEK OF THE MONTH OF
OCTOBER OF EVERY YEAR AS SENIOR CITIZENS WEEK, PROVIDING
FUNDS THEREFOR AND FOR OTHER PURPOSES.

WHEREAS, the Senior Citizens, despite of their age, play a vital role in nation building, particularly in barangay and community development through the sharing of their skills, experiences and expertise;

WHEREAS, in recognition of their valuable contribution and by way of encouraging them to actively participate in public service and local governance, Republic Act No. 7432, as amended by Republic Act No. 9257, was enacted by the Congress of the Philippines granting them certain benefits and privileges;

WHEREAS, to further enhance the importance and promote the welfare of the Senior Citizens, there is a need to declare the third week of the month of

October as the "Senior Citizen's Week where the Municipal elders could rightfully and timely hold festivities and celebration to show their ongoing activities, achievements, plans and other concerns.

NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN IN REGULAR SESSION ASSEMBLED:

SECTION 1. It is hereby declared that the 3rd Week of the month of October is the "Senior Citizen's Week" which shall be celebrated annually in the Municipality of Pavia.

SECTION 2. In observance thereof, the Office of the Senior Citizens' Affairs (OSCA), Municipality of Pavia, shall take charge in the overall implementation of this ordinance and, thus, spearhead various activities to highlight the history, achievements, plans and other concerns of the Senior Citizens.

SECTION 3. The following activities are to be undertaken in Celebration of the Senior Citizen's Week, but not limited to the following:

3.a. Senior Citizen's Governance Week - It shall include the election or selection from among the Municipality's Senior Citizen's Associations of the counterparts of all local elective and appointive officials, as well as the Heads of Department of the Local Government Unit of Pavia. During the said week, they shall hold office as Senior Citizens officials and shall perform such duties and conduct such activities appurtenant to the office they are representing or as may be designated by the concerned elective or appointive officials, provided that the service rendered by said Senior Citizen shall be without any compensation.

3.b. Recognition of Outstanding Senior Citizens

3.c. Thanksgiving Mass

3.d. Walk for Life

3.e. Showcase of Talent

3.f. Games

SECTION 4. All departments and offices in the Municipality of Pavia are hereby enjoined to extend assistance, courtesy and cooperation with OSCA and their counterparts to successfully attain the purpose of this ordinance.

SECTION 5. The amount of at least but not limited to Three Hundred Thousand Pesos (P300,000.00) is hereby appropriated to be



drawn from the Financial Assistance Fund of the Office of the Municipal Mayor as an initial fund to cover the necessary expenditures of the week-long celebration, subject to the existing accounting and auditing rules.

Thereafter, the succeeding appropriations shall be regularly included in the Annual Budget of Municipality of Pavia.

SECTION 6. The Office of the Municipal Mayor, through the OSCA, shall issue the necessary guidelines or rules and regulations for the effective, efficient and economical implementation thereof.

SECTION 7. The Head of the OSCA shall submit a report to the Office of the Municipal Mayor, copy furnished the Sanggunian Bayan, as to the highlights of the week-long activities.


SECTION 8. This Ordinance shall take effect immediately upon its approval.

BE IT ORDAINED FURTHER, to furnish copies of this Ordinance 2023-25 to all concerned for information and appropriate action.


