MUNICIPAL ORDINANCE 2023-39

ORDINANCE GRANTING FRANCHISE TO OPERATE MOTORIZED TRICYCLE FOR HIRE (MTH) TO PRECYL PASADILLA.

**WHEREAS;** Section 447 of Republic Act No. 7160 otherwise known as "Local Government Code of the Philippines" provides the Powers, Duties, Functions and Compensation, to wit: "(a) *The Sangguniang Bayan, as legislative body of the municipality, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants pursuant to Section 16 of this code and in the proper exercise of the corporate powers of the municipality as provided for under section 22 of this code shall:*

(3). Subject to the provisions of Book II of this code, grant franchises, enact ordinances authorizing the issuance of permits or licenses, or enact ordinances levying taxes, fees and charges upon such conditions and for such purposes intended to promote the general welfare of the inhabitants of the municipality and pursuant to the legislative authority shall:

(vi). Subject to the guidelines prescribed by the Department of Transportation and Communications, regulate the operation of tricycles and grant franchises for the operation thereof within the territorial jurisdiction of the municipality.

**NOW THEREFORE, BE IT ORDAINED** by the Sangguniang Bayan of Pavia, Iloilo in a regular session duly assembled, that:

**Section 1. Legal Basis.** Section 447 (a) (3) (vi) of Republic Act 7160 otherwise known as the Local Government Code of 1991.

**Section 2. Grant of Franchise.** Franchise to operate tricycle-for-hire is hereby granted to the following:

**Section 3. Franchise to Operate Motorcycle for Hire.** The Grantee shall be issued a Franchise to Operate Motorcycle for Hire that shall be signed by the Chairperson and all the members of the Committee on Transportation and Franchising. The Franchise Confirmation shall be approved by the Municipal Mayor and shall be prominently displayed inside the sidecar of the tricycle unit at all times.

**Section 4. Withdrawal, Cancellation, Revocation or Suspension of Franchise.** In case of violation by the Grantee of the terms and conditions and/or requirements provided herein and pertinent laws, ordinances, rules and regulations now existing and those that may hereinafter be promulgated, the Municipality of Pavia, through the Sangguniang Bayan, has the right to withdraw, cancel, revoke or suspend the franchise.

**Section 5. Repealing Clause.** All ordinances, in conflict or inconsistent herewith are hereby repealed or modified accordingly.


**Section 6. Separability Clause.** In the event that any provision of this Ordinance is declared illegal, the validity of other provisions shall not be affected by such declarations which shall continue to be in full force and effect.


**Section 7. Effectivity.** This Ordinance shall take effect immediately, in accordance with the provisions of the Local Government Code of 1991.
