IT IS ORDERED BY THE SANGGUNIANG BAYAN THAT THE

MUNICIPAL ORDINANCE NO. 2023-44

ORDINANCE FOR THE TEMPORARY CLOSURE OF THE ROAD FROM  
CIRCUMFERENTIAL ROAD (PAVIA) TOWARDS PORTION OF NINOY  
AQUINO AND CORAZON AQUINO INTERSECTION (RIGHT LANE ONLY),  
NINOY AQUINO HIGHWAY TOWARDS UNGKA 1, AGANAN, MALI-AO,  
CABUGAO SUR (RIGHT LANE ONLY) BACK TO MALI-AO (LEFT LANE  
ONLY), AGANAN (LEFT LANE ONLY), UNGKA 1 (LEFT LANE ONLY),  
UNGKA 2 TOWARDS THE BOUNDARY OF PAVIA AND ILOILO CITY (LEFT  
LANE ONLY) FOR THE 1<sup>ST</sup> ILOILO CITY OF LOVE INTERNATIONAL  
MARATHON ON DECEMBER 03, 2023 FROM 1:30 A.M. TO 7:00 A.M.

**WHEREAS**, there is a necessity for the temporary closure of portions of  
the above-mentioned roads to ensure the safety of the participants of the 1<sup>ST</sup>  
Iloilo City of Lova International Marathon 2023 on December 3, 2023 from 1:30  
AM to 7:30 AM;

**WHEREAS**, Local Government Code of 1991, Section 21. Closure and  
Opening of Roads.

(a) A local government unit may, pursuant to an ordinance, permanently or temporarily close or open any local road, alley, park, or square falling within its jurisdiction: Provided, however, that in case of permanent closure, such ordinance must be approved by at least two-thirds (2/3) of all the members of the Sanggunian, and when necessary, an adequate substitute for the public facility that is subject to closure is provided.

(b) No such way or place or any part thereof shall be permanently closed without making provisions for the maintenance of public safety therein. A property thus permanently withdrawn from public use may be used or conveyed for any purpose for which other real property belonging to the local government unit concerned may be lawfully used or conveyed: Provided, however, that no freedom park shall be closed permanently without provision for its transfer or relocation to a new site.

(c) Any national or local road, alley, park, or square may be temporarily closed during an actual emergency, or fiesta celebrations, public rallies, agricultural or industrial fairs, or an undertaking of public works and highways, telecommunications, and waterworks projects, the duration of which shall be specified by the local chief executive concerned in a written order: Provided, however, That no national or local road, alley, park, or square shall set temporarily closed for athletic, cultural, or civic activities not officially sponsored, recognized, or approved by the local government unit concerned.

**NOW THEREFORE, PREMISES CONSIDERED, AND UPON THE RECOMMENDATION OF THE SB COMMITTEE ON TRANSPORTATION, BE IT ORDAINED** by the Sangguniang Bayan of Pavia, Iloilo in a REGULAR SESSION duly assembled, that:

**Section 1.** An Ordinance for the temporary closure of the road from Circumferential road ( Pavia) towards portion of Ninoy Aquino and Corazon Aquino Intersection (right lane only), Ninoy Aquino Highway towards Ungka I, Aganan, Mali-ao, Cabugao Sur ( right lane only) back to Mali-ao (left lane only), Aganan (left lane only), Ungka 1 (left lane only), Ungka 2 towards the boundary of Pavia and Iloilo City (left lane only) for the 1<sup>st</sup> Iloilo City of Love International Marathon on December 3, 2023 from 1:30 A.M. to 7:00 A.M., be approved.

**Section 2.** The PTMO, Pavia PNP and barangay concerned be furnished copies of this ordinance for their information and appropriate action. The enforcement of the closure shall be subject to the prior announcement or information dissemination at the expense of the organizers for at least three (3) consecutive days prior to the scheduled closure;

**Section 3.** This ordinance shall take effect upon approval.

**BE IT ORDAINED FURTHER,** to furnish copies of this Ordinance

2023-44 to all concerned for information and appropriate action.

**ENACTED** on the 20<sup>th</sup> day of November, 2023 at Pavia, Iloilo, Philippines.


