MUNICIPAL ORDINANCE 2023-59

AN ORDINANCE REGULATING THE SALE OF VOLATILE SUBSTANCE/ SOLVENTS TO MINORS IN ALL BUSINESS ESTABLISHMENTS.

Be it **ORDAINED** by the Sangguniang Bayan of Pavia, Iloilo in session assembled, that:

SECTION 01. TITLE. This Ordinance shall be known as the "REGULATING THE SALE OF VOLATILE SUBSTANCE/ SOLVENTS TO MINORS"

SECTION 02. SCOPE. This Ordinance shall apply within the Territorial Jurisdiction of Pavia, Province of Iloilo.

SECTION 03. DEFINITION OF TERMS. As used in this ordinance, the following terms are hereby defined as follows:

MINOR shall be any person who is below eighteen (18) years age.

SOLVENT shall mean to have based contact cement like rugby, vulca seal, fed seal, elasto seal, thinner and other similar materials which can cause addiction.

ESTABLISHMENT refers to hardware stores, sari-sari stores or any establishment engaged in selling goods and products to include solvents.

LOGBOOK- A record book kept by a store or hardware containing information of customer (name, address and purposes for buying a solvent product.)

SECTION 04. REGULATORY ACTS.

- Owners of commercial stores or business establishments shall be prohibited to sell volatile substance/solvents such as "rugby" to minors.

- Minors are prohibited to use rugby for addictive purposes.
- Business establishments are required to maintain a logbook where the name, address and purpose of customer in buying the substance shall be recorded.

SECTION 05. PENALTY.

1st OFFENSE -Fine of Two Thousand Five Hundred Pesos (P2,500.00); and

2nd OFFENSE - Revocation of Business Permit

SECTION 06. ENFORCEMENT. The Members of the Philippine National Police, SK Officials and Barangay Tanods are hereby directed to ensure the widest dissemination and strict implementation of this Ordinance.

SECTION 07. FUNDING. An initial funding shall be allocated under the Peace and Order and Public Safety (POPS) Fund of this Municipality.

SECTION 08. SEPARABILITY CLAUSE. If any provision of this Ordinance found to be inconsistent with any law, other provisions or part/s thereof not so affected shall remain in full force and effect.

SECTION 09. REPEALING CLAUSE. All Ordinances, Rules and Regulations or parts thereof, in conflict with, or contrary to, the Provisions of this Ordinance not so affected herewith is hereby repealed or modified accordingly.

SECTION 10. EFFECTIVITY. This ordinance shall take effect after complying the requirements set forth in the Local Government Code of 1991.
