RESOLUTION URGING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS-REGIONAL OFFICE 6 TO UPDATE THE SANGGUNIANG BAYAN OF PAVIA, ILOILO REGARDING THE STATUS OF AGANAN FLYOVER.

WHEREAS, Section 16 of the Local Government Code of 1991 (RA No. 7160) states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, the Aganan Flyover is located at Barangay Aganan, Pavia, Iloilo. International Builders Corporation started the construction of Aganan Flyover on July 6, 2020, with a construction period of twenty-four (24) months;

WHEREAS, the Aganan Flyover is 436.9 lineal meters long on a board pile foundation, including the approaches, and still unfinished as of this time. The budget of the Aganan Flyover project is Five Hundred Sixty Million Pesos (P560,000,000.00);

WHEREAS, Pavianhons have been inconvenienced with the heavy traffic caused by the delayed project completion of Aganan Flyover. All commuters, especially employees and students, are significantly affected for they have to endure more than one (1) hour of travel from Pavia to Iloilo City and vice versa;

WHEREAS, with the current status of its construction, various inquiries are received from our constituencies triggered by concerns related to the disruption of transport accessibility, safety issues, design conformance, soil test results, and others.

NOW THEREFORE, on motion of Honorable Jose Maria D. Trimañez and duly seconded by Honorable Leonardo L. Belasa,

BE IT RESOLVED, AS IT IS HEREBY RESOLVED, TO PASS A RESOLUTION RESOLUTION URGING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS-REGIONAL OFFICE 6 TO UPDATE THE SANGGUNIANG BAYAN OF PAVIA, ILOILO REGARDING THE STATUS OF AGANAN FLYOVER.
