RESOLUTION ADOPTING RESOLUTION NO. 2022-650 OF THE SANGGUNIANG PANLALAWIGAN EMBODYING PROVINCIAL ORDINANCE 2022-286 ENTITLED "AN ORDINANCE CREATING THE PROVINCIAL TASK FORCE AND TECHNICAL WORKING GROUP, AND ADOPTING AND IMPLEMENTING THE BANTAY ASF SA BARANGAY OR THE BABAY ASF PROGRAM IN THE PROVINCE OF ILOILO AND PROVIDING POWERS THEREOF AND FOR OTHER PURPOSES."
