RESOLUTION REMANDING ORDINANCE NO. 2022-02 OF BARANGAY BALABAG, PAVIA, ILOILO ENTITLED "AN ORDINANCE IMPLEMENTING THE BARANGAY IDENTIFICATION SYSTEM TO EVERY RESIDENT OF BARANGAY BALABAG, PAVIA, ILOILO".

WHEREAS, Section 447 of RA 7160 provides the Powers, Duties and Functions of a Sangguniang Bayan which includes among others, "Approve ordinances and pass resolutions necessary for an efficient and effective municipal government, and in this connection shall review all ordinances approved by the Sangguniang Barangay and executive orders issued by the Punong Barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and of the Punong Barangay;

WHEREAS, the subject barangay ordinance was reviewed by the SB Committee on Revenue Generation and Good Government;

WHEREAS, after thorough deliberation, Committee Report 2023-02 dated January 16, 2023 was rendered and adopted;

WHEREAS, a copy of this resolution should be furnished to the Barangay Council of Barangay Balabag, Pavia, Iloilo for information and appropriate action;

NOW THEREFORE, on motion of Honorable Ariel B. Gerada and duly seconded by Honorable Jose Maria D. Trimañez,
