MARKET ROAD, BALABAG-JIBAO-AN FARM TO MARKET ROAD, WESTVILLE
ROAD (PANDAC), AND VILLA JUANITA ROAD (ANILAO), ALL IN PAVIA,
ILOILO.

serve as major access to the adjacent barangays and neighboring municipalities;


NOW THEREFORE, on motion of Honorable Roy H. Gorriceta, Sr. and duly seconded unanimously;


