RESOLUTION ADOPTING THE MUNICIPAL DEVELOPMENT COUNCIL (MDC) RESOLUTION NO. 2023-01 ENTITLED "A RESOLUTION APPROVING THE SUPPLEMENTAL 1 ANNUAL INVESTMENT PROGRAM FOR CY 2023 PROGRAMS, PROJECTS AND ACTIVITIES (PPAs) FUNDED FROM THE GENERAL FUND (GF), TRUST FUND (TF), AND OTHER CHARGES (DPWH) IN THE AMOUNT OF ONE HUNDRED FIFTY ONE MILLION EIGHT HUNDRED EIGHTY TWO THOUSAND PESOS (PHP 151,882,000.00)".


RESOLVED FURTHER, that copies of this resolution be forwarded to the concerned departments and agencies for reference and appropriate action.
