RESOLUTION NO. 2023-125

RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT (MOA) WITH THE ILOILO PROVINCIAL GOVERNMENT, THE DIFFERENT LGUs IN THE PROVINCE OF ILOILO AND WESTERN VISAYAS MEDICAL CENTER AND FURTHER AUTHORIZING HONORABLE LAURENCE ANTHONY G. GORRICETA, MUNICIPAL MAYOR, PAVIA, ILOILO TO SIGN THE MOA FOR AND IN BEHALF OF THE MUNICIPALITY OF PAVIA, ILOILO FOR THE PARTNERSHIP WITH THE WESTERN VISAYAS MEDICAL CENTER AS THE APEX HOSPITAL OF THE PROVINCIAL HEALTH CARE PROVIDER NETWORK (HCPN).

WHEREAS, presented for consideration of the Sangguniang Bayan was the endorsement from the Office of the Municipal Mayor relative to the above-mentioned Memorandum of Agreement (MOA);

WHEREAS, DOH Administrative Order No. 2020-0019 provides that Apex hospitals shall be linked to HCPNs and shall deliver specialty health care services not expected to be provided in HCPNs;

WHEREAS, the said DOH AO provides further that HCPN shall enter into a Memorandum of Agreement (MOA) with at least one apex hospital;

WHEREAS, the Western Visayas Medical Center is an identified Apex Hospital by the Department of Health;

WHEREAS, the SB Committee on Health to which this measure was referred hereby recommended for its approval as indicated in Committee Report 2023-38 dated March 13, 2023;


NOW THEREFORE, on motion of Honorable Rhia B. Sotomil and duly seconded by Honorable Ariel B. Gerada;

Gorriceta, Municipal Mayor, Pavia, Iloilo to sign the MOA for and in behalf of the Municipality of Pavia, Iloilo for the partnership with the Western Visayas Medical Center as the Apex Hospital of the Provincial Health Care Provider Network (HCPN).


RESOLVED FURTHER, that copies of this resolution be furnished to the parties concerned for information and appropriate action.
