RESOLUTION NO. 2023-127

RESOLUTION DECLARING THE HEREIN APPROPRIATION ORDINANCE NO. 2022-002 DATED OCTOBER 01, 2022 OF BARANGAY PUROK IV, PAVIA, ILOILO IN THE AMOUNT OF FOUR MILLION FOUR HUNDRED EIGHTY THOUSAND NINE HUNDRED FORTY ONE PESOS AND 69/100 (PHP P4,480,941.69) FOR ITS ANNUAL BUDGET FOR CALENDAR YEAR 2023 AS OPERATIVE IN ITS ENTIRETY.

WHEREAS, Section 447.1.i of the Local Government Code of 1991 (LGC) provides that the Sangguniang Bayan shall review all ordinances approved by the sangguniang barangay to determine whether these are within the scope of the prescribed powers of the sanggunian;

WHEREAS, the preliminary review was undertaken by the Local Finance Committee as per request of the SB Committee on Appropriation;

WHEREAS, presented for consideration of the Body is Committee Report No. 2023-39 dated March 13, 2023 of the SB Committee on Appropriation relative to Appropriation Ordinance No. 2022-02 of Barangay Purok IV, Pavia, Iloilo;

WHEREAS, as per Committee Report 2023-39 dated March 13, 2023 attached as "ANNEX A", the SB Committee on Appropriation recommends for the passage of a resolution declaring the appropriation ordinance of afore-mentioned barangay as operative in its entirety, in consideration of the findings and recommendations of the Local Finance Committee, subject to the conditions that the review does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law;

WHEREAS, the afore-mentioned Appropriation Ordinance for the Barangay Budget of BARANGAY PUROK IV is considered operative subject to compliance of related issuances pertaining to:

- payments of the following benefits such as: honorarium of barangay officials, mid-year benefits, year-end benefits, cash gift, productivity enhancement incentive and annual leave benefits;
- appropriation, release, planning, budgeting and utilization of 10% SK Fund should be consistent with DBM-DILG-NYC Joint Memorandum Circular No.1 dated January 23, 2019;
- projects funded under the 20% Development Fund, provided that these are embodied in the approved Annual Investment Plan of the Barangay and consistent with the priorities prescribed under the Joint Memorandum Circular issued by the Department of the Interior and Local Government (DILG) and Department of Budget and Management (DBM);
- utilization of at least 5% of the total appropriation identified in the GAD Plan, in accordance with RA 7192;
- disbursement of at least 5% LDRRMF (Local Disaster Risk Reduction Management Fund) shall be in accordance with RA10121 and its Implementing Rules and Regulations.

WHEREAS, the obligations and disbursement of Annual Budget shall not exceed the amount authorized by the Sangguniang Barangay, and subject to existing budgeting, accounting and auditing rules and regulations;

WHEREAS, the appropriation for Personal Services shall not exceed the 55% PS limitation set forth in the Local Government Code;

WHEREAS, the programs, projects and activities of the barangay shall provide appropriation to the following:

- Senior Citizen and PWD
- Nutrition Program
- Barangay Peace and Order Program
- Barangay Anti-Drug Abuse Program
- Violence against Women and Children
- PPAs to combat HIV/AIDS

WHEREAS, Special Purpose Appropriation should be appropriately provided for the following:

- 20 % Development Fund
- 10 % SK Fund
- 5 % BDRRMF

WHEREAS, the accuracy of the financial statements and other supporting documents as well as the compliance with and observance of all existing laws, rules and regulations contained in this budget shall be the responsibility of the barangay concerned;




RESOLVED FURTHER, that copies of this resolution be furnished to all barangays concerned for information and appropriate action.
