WHEREAS, presented for consideration of the August Body is the Optimum Agreement between the Need Ink Sales and Services to be represented by General Manager, Engr. Roy A. Mangubat and the Municipality of Pavia, Iloilo to be represented by Honorable Laurence Anthony G. Gorriceta relative to the provision of free printer for the use of Municipal Assessor's Office, Pavia, Iloilo;


RESOLVED FURTHER, that copies of this resolution be furnished to the parties concerned for information and appropriate action.
