**RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT WITH THE  
PROVINCIAL GOVERNMENT OF ILOILO FOR THE IDENTIFICATION OF  
BENEFICIARIES, CONSTRUCTION AND COMMISSIONING OF BARANGAY  
SANITARY TOILETS IN THE MUNICIPALITY OF PAVIA, ILOILO.**

**WHEREAS**, presented for consideration of the August Body is the endorsement from the Local Chief Executive relative to the above-named Memorandum of Agreement;

**WHEREAS**, this project known as the "Zero Open Defecation Movement of Iloilo Province" seeks to promote sanitation and hygiene, thus reduce the spread of diseases;

**WHEREAS**, the "Province of Iloilo" will provide one (1) toilet bowl, two (2) bags of cement, two (2) pieces PVC Sanitary Pipes-four inches in diameter, two (2) pieces PVC Sanitary Elbow-4 inches diameter for every beneficiary;

**WHEREAS**, the said Memorandum of Agreement consisting of five (5) pages will form part of this resolution and will be referred to as ANNEX "A";

**WHEREAS**, the Committee on Health to which this measure was referred hereby recommended for its approval as indicated in Committee Report 2023-18 dated February 06, 2023;

**RESOLVED FURTHER**, that copies of this resolution be furnished to the parties concerned for information and appropriate action.


