RESOLUTION AUTHORIZING HONORABLE LAURENCE ANTHONY G. GORRICETA, MUNICIPAL MAYOR, PAVIA, ILOILO TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE PROVINCIAL GOVERNMENT OF ILOILO FOR THE IDENTIFICATION OF BENEFICIARIES, CONSTRUCTION AND COMMISSIONING OF BARANGAY SANITARY TOILETS IN THE MUNICIPALITY OF PAVIA, ILOILO.

WHEREAS, presented for consideration of the August Body is the endorsement from the Local Chief Executive relative to the above-named Memorandum of Agreement;

WHEREAS, this project known as the "Zero Open Defecation Movement of Iloilo Province" seeks to promote sanitation and hygiene, thus reduce the spread of diseases;

WHEREAS, the "Province of Iloilo" will provide one (1) toilet bowl, two (2) bags of cement, two (2) pieces PVC Sanitary Pipes-four inches in diameter, two (2) pieces PVC Sanitary Elbow-4 inches diameter for every beneficiary;

WHEREAS, the said Memorandum of Agreement (MOA) consisting of five (5) pages will form part of this resolution and will be referred to as ANNEX "A";

WHEREAS, the Committee on Health to which this measure was referred hereby recommended for its approval as indicated in Committee Report 2023-18 dated February 06, 2023;

WHEREAS, the Sangguniang Bayan Office will be furnished a copy of the signed Memorandum of Agreement (MOA);


