LOCAL GOVERNMENT (DILG) FOR THE PROVISION OF 1,000 GALLON  
CAPACITY FIRE TRUCK TO THE MUNICIPALITY OF PAVIA, ILOILO.**

**WHEREAS**, Section 16 of the Local Government Code of 1991 (RA No. 7160) states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

**WHEREAS**, there is a need to acquire modern and new fire trucks and equipment in order for the municipality to efficiently suppress and effectively prevent destructive fires and provide emergency rescue services;

**RESOLVED FURTHER**, that copies of this resolution be furnished to all concerned for information and appropriate action.


