RESOLUTION NO. 2023-64

RESOLUTION AUTHORIZING HONORABLE LAURENCE ANTHONY G. GORRICETA, MUNICIPAL MAYOR, PAVIA, ILOILO TO ENTER AND SIGN THE MEMORANDUM OF UNDERSTANDING (MOU) BETWEEN THE MUNICIPALITY OF PAVIA, ILOILO AND THE COMMISSION ON POPULATION AND DEVELOPMENT (POPCOM) REGION 6 RELATIVE TO THE LOCALIZATION STRATEGY OF THE PHILIPPINE POPULATION AND DEVELOPMENT PROGRAM (PPDP).

WHEREAS, presented for consideration of the August Body is the Memorandum of Agreement (MOA) relative to the *above-mentioned measure* attached as ANNEX "A";

WHEREAS, with the full devolution of the provision of basic services and facilities to the LGUs as per Executive Order No. 138 and Mandanas-Garcia Ruling, national government agencies can assume strategic and steering functions to address persistent development issues;

WHEREAS, Section 3 of RA No. 7160 provides the operative principles of decentralization that shall guide the formulation of policies and measures on local autonomy;

WHEREAS, the Local Government Code devolved to the LGUs the primary responsibility of attaining and ensuring the welfare and development of its people and their localities through the provision of appropriate services including population and family planning services;

WHEREAS, the Philippine Development Plan (PDP) 2017-2022 lays down the national development blueprint for a more inclusive growth, a high trust and resilient society, and globally competitive knowledge economy that is anchored on AMBISYON

Natin 2040 to which all government entities at all levels shall contribute to attain as mandated by Executive Order No. 27 (s.2017);

WHEREAS, the Commission on Population and Development (POPCOM) is the government agency mandated to be central policy-making, planning, coordinating, and monitoring body of the Philippine Population and Development Program (PPDP) that is being implemented at the local government units;

WHEREAS, in support of the implementation of the National Program on Population and Family Planning (NPPFP), DILG Circular No. 2019-100 was issued to specifically enjoin LGUs to designate or appoint Local Population Officers and mobilize all relevant local offices and instrumentalities for the intensified implementation of the NPPFP particularly at the community level;

WHEREAS, under the same Cabinet Directive, POPCOM and the Department of Health (DOH) as institutional co-managers of the NPPFP, were madated to provide technical support to government agencies and LGUs in the development, implementation, and evaluation of the NPPFP strategies;

WHEREAS, as emerging national concerns and as part of the priority issues of the NPPFP, there ia an urgent need for all government agencies at al levels to take action to reduce the increasing incidence of early pregnancies among adolescents;

WHEREAS, the Sangguniang Bayan Office shall be furnished a copy of the signed MEMORANDUM OF AGREEMENT (MOA) for documentation purposes;


NOW THEREFORE, on motion of Honorable Jo Jan Paul J. Peñol and duly seconded by Honorable Ariel B. Gerada,

RESOLVED, as it is hereby resolved to pass a *RESOLUTION AUTHORIZING HONORABLE LAURENCE ANTHONY G. GORRICETA, MUNICIPAL MAYOR, PAVIA, ILOILO TO ENTER AND SIGN THE MEMORANDUM OF UNDERSTANDING (MOU) BETWEEN THE MUNICIPALITY OF PAVIA, ILOILO AND THE COMMISSION ON POPULATION AND DEVELOPMENT (POPCOM) REGION 6 RELATIVE TO THE LOCALIZATION STRATEGY OF THE PHILIPPINE POPULATION AND DEVELOPMENT PROGRAM (PPDP).*


RESOLVED FURTHER, that copies of this resolution be furnished to all concerned agencies for information and appropriate action.
