RESOLUTION 2023-77

RESOLUTION AUTHORIZING THE HONORABLE LAURENCE ANTHONY G. GORRICETA, MUNICIPAL MAYOR, PAVIA, ILOILO TO SIGN THE DEED OF DONATION WITH THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES-ENVIRONMENTAL MANAGEMENT BUREAU (DENR-EMB) REGION VI FOR THE PROVISION AND DONATION OF A BRAND NEW BIODEGRADABLE WASTE SHREDDER (BWS) AND BRAND NEW ROTARY DRUM COMPOSTER WITH HEATER, BAFFLES, AND ENZYME INJECTION SYSTEM.

WHEREAS, presented for consideration of the August Body is the Deed of Donation attached as ANNEX "A" consisting of two (2) pages relative to the donation of ONE (1) UNIT OF BIODEGRADABLE WASTE SHREDDER WITH A MINIMUM CAPACITY OF 250 KILOGRAMS, POWERED BY 12 HP DIESEL ENGINE WITH ELECTRIC AND MANUAL START, COMPOSED OF SHREDDING CHAMBER, SHREDDER BLADES; AND ONE (1) UNIT OF COMPOSTER WITH A CAPACITY OF 1,000 KILOGRAMS PER BATCH FOR EVERY 24 HOURS' OPERATION POWERED BY FIVE (5) HP BY ELECTRIC MOTOR, 220 V,60HZ, SINGLE PHASE WITH SPEED REDUCER 1:10 TYPE 120;

WHEREAS, Section 3 of RA 9003 states that DENR shall provide technical and other capability building assistance and support to the LGUs in the development and implementation of local solid waste management plans and programs;

WHEREAS, the Municipality of Pavia, Iloilo agreed to fulfill its requirements under the terms and conditions stipulated in the MOA and Deed of Donation;

WHEREAS, the Sangguniang Bayan of Pavia, Iloilo has already issued the following resolutions (please refer to the appendices):

1). the Mayor and other concerned agencies for information and appropriate action.


