**MUNICIPAL ORDINANCE 2024-01**

**ORDINANCE EXTENDING THE DEADLINE OF THE RENEWAL OF BUSINESS PERMITS AND LICENSES WITHOUT SURCHARGES AND INTERESTS FROM JANUARY 20, 2024 TO JANUARY 26, 2024 TO GIVE AMPLE TIME TO BUSINESSMEN TO RENEW BUSINESS PERMITS AT ROBINSON'S PLACE-PAVIA, BARANGAY UNGKA II, PAVIA, ILOILO.**

WHEREAS, as represented by the Municipal Treasurer – Ms. Caroline Teruel and endorsed by the Local Chief Executive, there is a need to extend the deadline on the payment of business taxes and renewal of permits and licenses to January 26, 2024, without penalties and surcharges;

NOW THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF PAVIA, ILOILO, BY VIRTUE OF THE POWERS VESTED IN IT BY LAW, IN SESSION ASSEMBLED, THAT:

**Section 1. Title.** *ORDINANCE EXTENDING THE DEADLINE OF THE RENEWAL OF BUSINESS PERMITS AND LICENSES WITHOUT SURCHARGES AND INTERESTS FROM JANUARY 20, 2024 TO JANUARY 26, 2024 TO GIVE AMPLE TIME TO BUSINESSMEN TO RENEW BUSINESS PERMITS AT ROBINSON'S PLACE-PAVIA, BARANGAY UNGKA II, PAVIA, ILOILO*, be approved.



**Section 2. Repealing Clause.** All ordinances, as well as pertinent rules and regulations thereof, which are inconsistent with the provisions of this ordinance are hereby repealed or amended accordingly.

**Section 3. Effectivity.** This Ordinance shall take effect immediately after complying the requirements provided for in the Local Government Code.

**BE IT ORDAINED FURTHER,** to furnish copies of this Ordinance to all concerned agencies for information and appropriate action.
