MUNICIPAL ORDINANCE 2024-07

ORDINANCE FOR THE TEMPORARY CLOSURE OF THE NIA BYPASS ROAD WHICH CONNECTS FELIX GORRICETA, JR. AVENUE AND ILOILO CIRCUMFERENTIAL ROAD 1 (C1 ROAD) SITUATED AT BARANGAY PANDAC, PAVIA, ILOILO ON MARCH 11, 2024 TO JUNE 11, 2024 (9:00 A.M. TO 4:00 P.M., AND 8:00 P.M. TO 10:00 P.M. FROM MONDAY TO SUNDAY.

WHEREAS there is a necessity for the temporary closure of portions of the above-mentioned roads as per endorsement of the Local Chief Executive (please refer to Annex A);

WHEREAS, Local Government Code of 1991, Section 21. Closure and Opening of Roads.

(a) A local government unit may, pursuant to an ordinance, permanently or temporarily close or open any local road, alley, park, or square falling within its jurisdiction: Provided, however, that in case of permanent closure, such ordinance must be approved by at least two-thirds (2/3) of all the members of the Sangguniang, and when necessary, an adequate substitute for the public facility that is subject to closure is provided.

(b) No such way or place or any part thereof shall be permanently closed without making provisions for the maintenance of public safety therein. A property thus permanently withdrawn from public use may be used or

conveyed for any purpose for which other real property belonging to the local government unit concerned may be lawfully used or conveyed: Provided, however, that no freedom park shall be closed permanently without provision for its transfer or relocation to a new site.

(c) Any national or local road, alley, park, or square may be temporarily closed during an actual emergency, or fiesta celebrations, public rallies, agricultural or industrial fairs, or an undertaking of public works and highways, telecommunications, and waterworks projects, the duration of which shall be specified by the local chief executive concerned in a written order: Provided, however, That no national or local road, alley, park, or square shall set temporarily closed for athletic, cultural, or civic activities not officially sponsored, recognized, or approved by the local government unit concerned.

NOW THEREFORE, PREMISES CONSIDERED, AND UPON THE RECOMMENDATION OF THE COMMITTEE ON TRANSPORTATION AS PROVIDED IN COMMITTEE REPORT 2024-21 DATED MARCH 04, 2024, BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF PAVIA, ILOILO IN A REGULAR SESSION DULY ASSEMBLED, THAT:

Section 1. *ORDINANCE FOR THE TEMPORARY CLOSURE OF THE NIA BYPASS ROAD WHICH CONNECTS FELIX GORRICETA, JR. AVENUE AND ILOILO CIRCUMFERENTIAL ROAD 1 (C1 ROAD) SITUATED AT BARANGAY PANDAC, PAVIA, ILOILO ON MARCH 11, 2024 TO JUNE 11, 2024 (9:00 A.M. TO 4:00 P.M., AND 8:00 P.M. TO 10:00 P.M. FROM MONDAY TO SUNDAY, be approved.*

Section 2. The PTMO, Pavia PNP and barangay concerned be furnished copies of this ordinance for their information and appropriate action. The enforcement of the closure shall be subject to the prior announcement or information dissemination at the expense of the organizers prior to the scheduled closure.

Section 3. This ordinance shall take effect upon approval.

BE IT ORDAINED FURTHER, to furnish copies of this Ordinance to the Sangguniang Panlalawigan of the Province of Iloilo for review, and other concerned agencies for information and appropriate action.


