ORDINANCE TO REPEAL MUNICIPAL ORDINANCE NO. 2023-52, AN ORDINANCE AMENDING SECTION 12 H. BENEFITS AND PRIVILEGES OF MUNICIPAL ORDINANCE NO. 2023-26 OTHERWISE KNOWN AS COMPREHENSIVE SOLO PARENTS ORDINANCE.

**WHEREAS**, the above-mentioned ordinance was submitted to the Sangguniang Panlalawigan for review;
