MUNICIPAL ORDINANCE 2024-13

ORDINANCE TO REPEAL MUNICIPAL ORDINANCE NO. 2023-54, AN ORDINANCE APPROVING THE REVISED REVENUE CODE OF 2023 OF MUNICIPALITY OF PAVIA, PROVINCE OF ILOILO.

WHEREAS, the above-mentioned ordinance was submitted to the Sangguniang Panlalawigan for review;

WHEREAS, Resolution No. 2024-113 attached as "ANNEX A" of the Sangguniang Panlalawigan remanded Municipal Ordinance No. 2023-54 of Pavia, Iloilo for appropriate action, without prejudice to its resubmission;

NOW THEREFORE, on motion of Honorable Rhia B. Sotomil, and duly seconded by Hon. Gerard Peter G. Zaldarriaga;

BE IT ORDAINED by the Sangguniang Bayan of Pavia, Iloilo in a regular session duly assembled, that:

"ORDINANCE TO REPEAL MUNICIPAL ORDINANCE NO. 2023-54, AN ORDINANCE APPROVING THE

REVISED REVENUE CODE OF 2023 OF MUNICIPALITY OF PAVIA, PROVINCE OF ILOILO, be approved".
