ORDINANCE 2024-25

AN ORDINANCE PROVIDING AWARDS AND REWARDS FOR OUTSTANDING TANODS IN THE MUNICIPALITY OF PAVIA, ILOILO.

=====

WHEREAS, the barangay tanod play a vital role in maintaining peace and order in the community;

WHEREAS, it is essential to recognize and reward the dedication, hard work, and bravery of barangay tanod to motivate them and others to perform their duties diligently;

NOW, THEREFORE, be it ordained by the Sangguniang Bayan of the Municipality of Pavia, Iloilo in a session duly assembled, that:

Section 1. Title. This ordinance shall be known as the "Outstanding Tanod Awards and Rewards Ordinance of Pavia, Iloilo."

Section 2. Objective. The objective of this ordinance is to establish a system for recognizing and rewarding outstanding tanod in the Municipality of Pavia, Iloilo to promote excellence and dedication in maintaining peace and order.

Section 3. Definition of Terms. The terms used in this ordinance shall be defined as follows:

* **Tanod** refers to a barangay security officer tasked with assisting in maintaining peace and order within the barangay.

***Outstanding Tanod** refers to a tanod who has shown exemplary performance, bravery, and dedication in the execution of their duties.

Section 4. Criteria for Selection. The selection of outstanding tanod shall be based on the following criteria:

1. Performance: Demonstrated exceptional performance in maintaining peace and order.
2. Bravery: Acted with bravery in situations that posed a risk to personal safety.
3. Dedication: Consistently performed duties beyond the call of duty.
4. Community Involvement: Active participation in community activities and programs.

Section 5. Selection Committee. A selection committee shall be formed to evaluate and select the outstanding tanod. The committee shall be composed of:

1. Municipal Mayor or their representative
2. Municipal Peace and Order Council (MPOC) Chairperson
3. Representative from the Sangguniang Bayan
4. Representative from the Liga ng mga Barangay- Municipal Chapter
5. Representative from the Civil Society Organizations (CSOs)

Section 6. Awards and Rewards. The outstanding tanod shall be given the following awards and rewards:

1. Certificate of Recognition: A formal certificate recognizing their exemplary service.
2. Monetary Reward: A cash incentive as determined by the Municipal Government.
3. Medal of Valor: A medal symbolizing their bravery and dedication.
4. Incentives Worth of Programs: Professional Development - Training and development programs to enhance skills and competencies.

Section 7. Funding. The necessary funding for the awards and rewards program shall be sourced from the municipal budget allocated for peace and order, or other available funds.

Section 8. Implementation. The Municipal Mayor shall be responsible for the implementation of this ordinance, with the assistance of the Municipal Peace and Order Council and the selection committee.

Section 9. Effectivity. This ordinance shall take effect immediately upon its approval.

ENACTED this 19TH day of August, 2024 at Pavia, Iloilo Philippines.
