ORDINANCE 2024-20

AN ORDINANCE CREATING VARIOUS PLANTILLA POSITIONS WHICH WERE INADVERTENTLY NOT INCLUDED IN THE REQUEST FOR SUPPLEMENTAL BUDGET PER SANGGUNIANG BAYAN APPROPRIATION ORDINANCE NO. 2024-02, AND APPROPRIATING FUNDS THERETO, TO WIT: (1) OFFICE OF THE MAYOR-4 CASUAL CLERKS (SG 1), 2 CASUAL CLERKS (UNDER PPSTMO) (SG 1); (2) SANGGUNIANG BAYAN OFFICE-1 LOCAL LEGISLATIVE STAFF ASSISTANT III (SG 10), 1 LOCAL LEGISLATIVE STAFF ASSISTANT I(SG 6), 1 LOCAL LEGISLATIVE STAFF EMPLOYEE I(SG 2); (3) MUNICIPAL TREASURER'S OFFICE-1 TICKET CHECKER (SG 3); (4) MUNICIPAL ASSESSOR'S OFFICE-2 CASUAL CLERKS(SG 1); (5) MUNICIPAL BUDGET OFFICE-1 ADMINISTRATIVE OFFICER V-BUDGET OFFICER III(SG 18); (6) GENERAL SERVICES OFFICE-1 PARKING AIDE IV(SG 7); (7) BUSINESS PERMIT AND LICENSING OFFICE(BPLO)-1 LICENSING OFFICER II(SG 15); (8) RURAL HEALTH UNIT -1 VETERINARIAN II(SG 16); (9) MUNICIPAL SOCIAL WELFARE AND DEVELOPMENT OFFICE-1 SOCIAL WELFARE OFFICER II(SG 15), 1 SPECIAL OPERATIONS OFFICER I(SG 10), 1 DISABILITY AFFAIRS ASSISTANT(SG 8), (10) MUNICIPAL ENGINEERING OFFICE-1 ARCHITECT I(SG 12), (11) MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICE-1 ADMINISTRATIVE AIDE III(DRIVER I SG 3).

WHEREAS, the Sangguniang Bayan Office received an endorsement from the Local Chief Executive for a legislative action pertaining to the above-mentioned subject attached as "Annex A";

WHEREAS, the SB Committee on Good Government to which this measure was referred, recommended for its approval as indicated in Committee Report 2024-90 dated June 10, 2024 attached as "Annex B";

WHEREFORE, be it enacted by the Sangguniang Bayan in session assembled that:

4. Municipal Assessor's Office
 - a). 2 Casual Clerks – SG 1
5. Municipal Budget Office
 - a). 1 Administrative Officer V (Budget Officer III) – SG 18
6. General Services Office
 - a). 1 Parking Aide IV – SG 7
7. Business Permit and Licensing Office (BPLO)
 - a). 1 Licensing Officer II – SG 15
8. Rural Health Unit
 - a). 1 Veterinarian II – SG 16
9. Municipal Social Welfare and Development Office
 - a). 1 Social Welfare Officer II – SG 15
 - b). 1 Special Operations Officer I – SG 10
 - c). 1 Disability Affairs Assistant – SG 8
10. Municipal Engineering Office
 - a). 1 Architect I – SG 12
11. Municipal Disaster Risk Reduction and Management Office
 - a). 1 Administrative Aide III (Driver I) – SG 3

SECTION 2. This Ordinance shall take effect upon complying the requirements prescribed under Republic Act 7160, Civil Service Commission and other related Agencies.


