RESOLUTION REQUESTING HONORABLE LAURENCE ANTHONY G. GORRICETA, MUNICIPAL MAYOR, PAVIA, ILOILO TO PRIORITIZE THE INCLUSION OF INSTALLATION OF TRAFFIC LIGHTS IN STRATEGIC INTERSECTIONS LIKE MALI-AO (IGLESIA NI CRISTO AND BISCOCHO HAUS), JIBAO-AN, BALABAG, ALL OF PAVIA, ILOILO, IN THE ANNUAL INVESTMENT PROGRAM (AIP) OF THE MUNICIPALITY OF PAVIA, ILOILO.

WHEREAS, the rapid growth and development of Pavia, Iloilo have led to increased vehicular traffic, posing challenges to road safety and traffic management;

WHEREAS, the intersections of Mali-ao (Iglesia ni Cristo and Biscocho Haus), Jibao-an, and Balabag are strategic locations that experience high volumes of traffic, resulting in congestion and potential safety hazards;

WHEREAS, the installation of traffic lights in these intersections would significantly improve traffic flow, reduce the risk of accidents, and enhance the overall safety of road users;

WHEREAS, the Annual Investment Program (AIP) of the Municipality of Pavia, Iloilo provides an opportunity to prioritize projects that address the needs and concerns of the community;

NOW, THEREFORE, on motion of Honorable Joshua Philippe B. Gumban, and duly seconded by Honorable Ariel B. Gerada;

RESOLVED, as it is hereby resolved, to pass a resolution requesting Honorable Laurence Anthony G. Gorriceta, Municipal Mayor, Pavia, Iloilo to prioritize the inclusion of installation of traffic lights in strategic intersections like Mali-ao (Iglesia Ni Cristo and Biscocho Haus), Jibao-an, Balabag, all of Pavia, Iloilo, in the Annual Investment Program (AIP) of the Municipality of Pavia, Iloilo.

RESOLVED FURTHER, that copies of this resolution be furnished to all concerned for their information and appropriate action.


