**RESOLUTION DESIGNATING THE CHAIRPERSON AND VICE
CHAIRPERSON OF THE COMMITTEE ON TRANSPORTATION AS
OFFICIAL SIGNATORIES IN THE APPROVAL OF APPLICATION FOR THE
RENEWAL OF FRANCHISE FOR MOTORIZED TRICYCLE FOR HIRE (MTH)
IN BEHALF OF THE SANGGUNIANG BAYAN.**

WHEREAS, pursuant to Section 447 (a) (3) (vi) of RA 7160, the Sangguniang Bayan shall "subject to guidelines prescribed by the Department of Transportation and Communications, regulate the operation of tricycles and grant franchises for the operation thereof within the territorial jurisdiction of the municipality;

WHEREAS, there are numerous applications for renewal of MTH franchise which is a great burden to the Sangguniang Bayan to tackle the said applications "EN BANC";

WHEREAS, it has already been a practice of the Sangguniang Bayan that such function of the Sangguniang Bayan is delegated to the Committee Chairperson and Vice Chairperson;

WHEREAS, consistent with the provisions of the Local Government Code, the application for new franchise shall be approved by the Sangguniang Bayan in a session duly assembled;

NOW THEREFORE, on motion of Honorable Joshua Philippe B. Gumban and duly seconded by Honorable Ludovico S. Alfaro;


