WHEREAS, the Local Government Unit of Pavia, Iloilo is committed to providing essential services to its constituents, particularly in times of crisis and emergencies;

WHEREAS, the LGU recognizes the pressing need for a Crisis Intervention Facility and Evacuation Center to effectively respond to and manage disaster situations, ensuring the safety and well-being of its residents;

WHEREAS, despite the LGU's best efforts, it lacks the necessary financial resources to fund the construction of the proposed 3-storey building, which will house the Crisis Intervention Facility and Evacuation Center;

WHEREAS, Congresswoman Kathryn Joyce Fermin Gorriceta has consistently demonstrated her commitment to the welfare and development of our community, and we believe that her office can provide the necessary support and assistance;


for the construction of a 3-storey building which will house the crisis intervention facility and evacuation center.
