RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE MUNICIPALITY OF PAVIA, ILOILO AND THE DEPARTMENT OF TRADE AND INDUSTRY (DTI)-ILOILO PROVINCIAL OFFICE, AND AUTHORIZING THE HONORABLE LAURENCE ANTHONY G. GORRICETA, MUNICIPAL MAYOR TO ENTER INTO AND SIGN THE SAID MOA ON BEHALF OF THE MUNICIPALITY.

WHEREAS, presented for consideration of the body, and referred to the SB Committee on Trade and Industry is the endorsement from the Office of the Mayor regarding the Memorandum of Agreement (MOA) for the renewal of the partnership between the Local Government Unit (LGU) of Pavia, Iloilo and the Department of Trade and Industry (DTI) - Iloilo Provincial Office concerning the continued operation of the Negosyo Center (NC) in Pavia, Iloilo;

WHEREAS, the MOA seeks to ensure the sustained operation of the Negosyo Center of Pavia, Iloilo to promote ease of doing business and facilitate or Micro Small and Medium Enterprises (MSMEs) access to business development services;

WHEREAS, in recognition of the continued support and assistance provided by the DTI to MSMEs within the Municipality of Pavia, Iloilo, the committee recommended for the approval of this resolution as indicated in Committee Report 2025-70 dated August 4, 2025;

WHEREAS, the responsibilities of both parties, and the terms and conditions are stipulated in the MOA, attached as "ANNEX A";


