WHEREAS, the Barangay Hall of Barangay Anilao, Pavia, Iloilo serves as the nerve center for delivering basic services to the community, and a functional and well-maintained hall is essential for efficient governance and public service;

WHEREAS, Brgy. Anilao, being one of the smallest barangays in Pavia, Iloilo, faces significant challenges in providing adequate facilities for its constituents due to limited resources;
