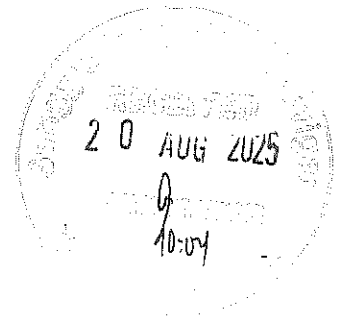

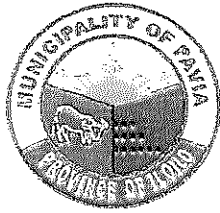

**Subject: 1. An Ordinance Institutionalizing "888" as the official emergency hotline of the Municipality of Pavia, Iloilo, and providing funds and mechanisms for its implementation**

**Findings and Recommendation:**

The committee discussed the proposed ordinance entitled: "An Ordinance Institutionalizing '888' as the Official Emergency Hotline of the Municipality of Pavia, Iloilo, and Providing Funds and Mechanisms for Its Implementation."

The "888" Emergency Hotline shall cater to the following services:

1. Emergency Medical Services
2. Fire and Rescue Services
3. Crime and Security Concerns
4. Disaster Response and Mitigation
5. Other Public Safety Emergencies

While the proposed ordinance is seen as an important component of the Municipality's Basic Emergency Response Communication System, the committee agreed on the following actions:

1. To further study the proposed ordinance;
2. To coordinate with PLDT to assess whether their system and infrastructure can accommodate specialized numbers;
3. To invite representatives from NTC and PLDT to the next committee meeting;
4. To check with Smart Telecommunications if they can issue a specialized mobile number (e.g., 0908-088-8880) for easier recall.


**Findings and Recommendation:**


