RESOLUTION APPROVING THE COMPROMISE AGREEMENT WITH THE TACLOBAN WINNER MARKETING CORPORATION AND FURTHER AUTHORIZING HON. LAURENCE ANTHONY GORRICETA, MUNICIPAL MAYOR, PAVIA, ILOILO TO ENTER AND SIGN INTO COMPROMISE AGREEMENT FOR THE REPLACEMENT OF THE DAMAGED FORD VEHICLE (RANGER 2.0L SPORT 4X4 6AT) WITH PLATE NO. SFA 1892 AND CR NO. 0055466297 OWNED BY THE MUNICIPAL GOVERNMENT OF PAVIA, ILOILO WITH A BRAND NEW VEHICLE WITH IDENTICAL SPECIFICATIONS AND SHALL TRANSFER THE OWNERSHIP OF THE DAMAGED FORD VEHICLE BY EXECUTING A DEED OF TRANSFER IN FAVOR OF TACLOBAN WINNER MARKETING CORPORATION.


