RESOLUTION 2025-127

RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM HONORABLE FERDINAND MARTIN ROMUALDEZ, SPEAKER, HOUSE OF REPRESENTATIVES IN THE AMOUNT OF TWO HUNDRED MILLION (P200,000,000.00) PESOS FOR THE PROPOSED ROAD CONNECTING THE SENATOR BENIGNO AQUINO AVENUE (DIVERSION ROAD) AT BARANGAY DUNGON, JARO, ILOILO CITY TO PRESIDENT CORAZON AQUINO AVENUE (ILOILO CIRCUMFERENTIAL ROAD 1) AT BARANGAY PANDAC, PAVIA, ILOILO WHICH WILL UTILIZE THE EXISTING 5-METER-WIDE CONCRETE ROAD WITHIN THE JURISDICTION OF ILOILO CITY AND THE EXISTING GRAVEL ROAD IN THE MUNICIPALITY OF PAVIA, ILOILO.

WHEREAS, one of the pressing needs of Iloilo City and the Municipality of Pavia, Iloilo is the improvement of road infrastructure to address increasing traffic congestion, ensure efficient mobility of goods and services, and provide safe and faster access for commuters and motorists;

WHEREAS, the proposed road project connecting Senator Benigno Aquino Avenue (Diversion Road) at Barangay Dungon, Jaro, Iloilo City to President Corazon Aquino Avenue (Iloilo Circumferential Road 1) at Barangay Pandac, Pavia, Iloilo will

utilize the existing 5-meter-wide concrete road within Iloilo City and the existing gravel road in the Municipality of Pavia;

WHEREAS, the construction and full development of this road link will serve as a critical alternative route, decongesting traffic along the Diversion Road and other major thoroughfares, thereby reducing travel time and transportation costs;

WHEREAS, the proposed road will not only improve traffic flow but will also enhance economic activities, providing a more efficient route for trade, commerce, and services between Iloilo City and its neighboring municipalities, especially Pavia, Iloilo which is rapidly emerging as a residential, commercial, and industrial hub;

WHEREAS, improved road connectivity will attract more investments, increase property values, facilitate job creation, and boost local revenues, directly benefiting both Iloilo City and the Municipality of Pavia, Iloilo;

WHEREAS, the Local Government Units (LGUs) of Iloilo City and Pavia, Iloilo recognize the urgent necessity of the project but lack sufficient financial resources to undertake such a huge capital-intensive infrastructure;

WHEREAS, the estimated project cost of Two Hundred Million Pesos (P200,000,000.00) is beyond the current budgetary capacity of the concerned LGUs, thus requiring the intervention of the National Government through the support of the Honorable Ferdinand Martin Romualdez, Speaker of the House of Representatives;

NOW, THEREFORE, on motion of Honorable Ariel B. Gerada, and duly seconded by Honorable Joshua Philippe B. Gumban;

RESOLVED, as it is hereby resolved, to pass a *RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM HONORABLE FERDINAND MARTIN ROMUALDEZ, SPEAKER, HOUSE OF REPRESENTATIVES IN THE AMOUNT OF TWO HUNDRED MILLION (P200,000,000.00) PESOS FOR THE PROPOSED ROAD CONNECTING THE SENATOR BENIGNO AQUINO AVENUE (DIVERSION ROAD) AT BARANGAY DUNGON, JARO, ILOILO CITY TO PRESIDENT CORAZON AQUINO AVENUE (ILOILO CIRCUMFERENTIAL ROAD 1) AT BARANGAY PANDAC, PAVIA, ILOILO WHICH WILL UTILIZE THE EXISTING 5-METER-WIDE CONCRETE ROAD WITHIN THE JURISDICTION OF ILOILO CITY AND THE EXISTING GRAVEL ROAD IN THE MUNICIPALITY OF PAVIA, ILOILO.*
