RESOLUTION NO. 2025-62

RESOLUTION APPROVING THE PROPOSED DISPOSITION AND ALLOCATION OF THE CAPITATION PAYMENT UNDER THE PHILHEALTH KONSULTASYONG SULIT AT TAMA (KONSULTA) PACKAGE, INCLUDING THE SHARING OF PERFORMANCE INCENTIVES FOR THE MUNICIPAL HEALTH OFFICE OF PAVIA, PROVINCE OF ILOILO.

WHEREAS, the Municipal Health Office of Pavia, Iloilo has been participating in the PhilHealth Konsultasyong Sulit at Tama (KONSULTA) program, which aims to provide accessible and affordable healthcare services to its constituents;

WHEREAS, the KONSULTA program provides capitation payments and performance incentives to healthcare providers who meet certain quality and performance standards;

WHEREAS, Iloilo Provincial Health Board approved Resolution 003, Series of 2025 pertaining to the disposition and allocation plan for the capitation payment and performance incentives received under the KONSULTA program;

WHEREAS, the proposed disposition and allocation plan aims to ensure that the funds are utilized effectively and efficiently to improve healthcare services and outcomes in the municipality;

WHEREAS, the SB Committee on Health and Sanitation recommended the approval of the above-mentioned resolution as indicated in Committee Report 2025-43 dated May 26, 2025;


NOW, THEREFORE, on motion of Honorable Rhia B. Sotomil, and duly seconded by Honorable Leonardo L. Belasa;

BE IT RESOLVED, as it is hereby resolved, to pass a resolution approving the proposed disposition and allocation of the capitation payment under the Philhealth Konsultasyong Sulit at Tama (KONSULTA) package, including the sharing of performance incentives for the Municipal Health Office of Pavia, Province of Iloilo.


BE IT FURTHER RESOLVED, to furnish a copy of this resolution to all relevant offices for information and appropriate action.
