RESOLUTION AUTHORIZING HONORABLE LAURENCE ANTHONY G. GORRICETA, MUNICIPAL MAYOR, PAVIA, ILOILO TO ENTER AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) WITH THE GOVERNMENT SERVICE INSURANCE SYSTEM (GSIS) FOR THE GSIS MPL BUY-OUT OPTION.

WHEREAS, presented for consideration of the Sangguniang Bayan is the endorsement from the Office of the Mayor relative to the above-mentioned Memorandum of Agreement (MOA) attached as "Annex A";

WHEREAS, the Government Service Insurance System (GSIS) offers the Maximum Loanable Policy (MLP) Buy-Out Option, a program designed to provide financial benefits to government employees;

WHEREAS, the Municipality of Pavia, Iloilo, seeks to participate in the GSIS MLP Buy-Out Option to avail of its benefits and improve the financial well-being of its employees;

WHEREAS, the Memorandum of Agreement (MOA) outlines the terms and conditions of the MLP Buy-Out Option, including the roles and responsibilities of both parties;

WHEREAS, the Sangguniang Bayan Office shall be furnished a copy of the signed agreement for documentation purposes;


NOW, THEREFORE, on motion of Honorable Rhia B. Sotomil, which was duly seconded by Honorable Daniel S. Fajardo II;
