**RESOLUTION NO. 2025-76**

**RESOLUTION DECLARING THE RESOLUTION NO. 003, SERIES OF 2025 DATED JANUARY 18, 2025 OF THE SANGGUNIANG KABATAAN OF BARANGAY JIBAO-AN, PAVIA, ILOILO AMOUNTING TO FOUR MILLION TWO HUNDRED ELEVEN THOUSAND FOUR HUNDRED TWENTY FIVE PESOS AND 97/100 (PHP 4,211,425.97) AS OPERATIVE IN ITS ENTIRETY.**

**WHEREAS**, Section 13b of RA 10742 known as "Sangguniang Kabataan Reform Act of 2015" provides the Powers and Functions of the Sangguniang Kabataan Chairperson, to wit: "Take the lead in the formulation of the Comprehensive Barangay Youth Development Plan and in the preparation and implementation of the Annual Barangay Youth Investment Program";

**WHEREAS**, Section 18 of the same Act provides ground for the Suspension and Removal from Office. Any elected official of the Sangguniang Kabataan may, after due process, be suspended for not more than six (6) months or removed from office by majority vote of all members of the Sangguniang Bayan which has jurisdiction in the barangay of the concerned Sangguniang Kabataan official which shall be final and executory, on any of the following grounds:

"(d) Failure to formulate the Comprehensive Barangay Youth Development Plan and the Annual Barangay Youth Investment Program, or approve the annual budget within the prescribed period of time without justifiable reason"

**WHEREAS**, Section 20C includes "Sangguniang Kabataan Funds. All Sangguniang Kabataan funds shall be allocated in an annual budget, and if the funds allow, in a supplemental budget in accordance with the adopted Annual Barangay Investment Program. Both the Comprehensive Barangay Youth Development Plan and Annual Barangay Investment Program shall give priority to programs, projects and activities that will promote and ensure the equitable access to quality education, environmental protection, climate change adaptation, disaster risk reduction and resiliency, youth employment and livelihood, health and anti-drug abuse, gender sensitivity, sports development, and capability building which emphasizes leadership training".

**WHEREAS**, Joint Memorandum Circular No. 1 Series of 2019 dated January 23, 2019 issued by the Department of Budget and Management (DBM) and the Department of the Interior and Local Government (DILG) provides the guidelines on the appropriation, release, planning and budgeting process of the SK Funds;

**WHEREAS**, Section 3.3.4.1 of the Joint Memorandum Circular No. 1 Series of 2019 dated January 23, 2019 issued by the Department of Budget and Management (DBM) and the Department of the Interior and Local Government (DILG) provides "the Sangguniang Bayan, as the case may be, shall within sixty (60) days upon receipt, review the annual/supplemental budget of the SK on their compliance with the priority programs, projects and activities identified under the Section 20 (c) of RA 10742, and with other existing laws, rules and regulations";


**NOW, THEREFORE**, on motion of Honorable Rhia B. Sotomil, and duly seconded by Honorable Daniel S. Fajardo, II,

**RESOLVED**, as it is hereby resolved to pass a **RESOLUTION DECLARING THE RESOLUTION NO. 003, SERIES OF 2025 DATED JANUARY 18, 2025 OF THE SANGGUNIANG KABATAAN OF BARANGAY JIBAO-AN, PAVIA, ILOILO AMOUNTING TO FOUR MILLION TWO HUNDRED ELEVEN THOUSAND FOUR HUNDRED TWENTY FIVE PESOS AND 97/100 (PHP 4,211,425.97) AS OPERATIVE IN ITS ENTIRETY.**


